*Subject : Grant of dearness relief to the Jharkhand Government pensioners/  
family pensioners with effect from 01-07-2019.*

In continuation to this office circular No. Pen. Co-ordn./Jharkhand/Vol.-II/DR/55 dated 09-07-2019, this is to state that the Government of Jharkhand in their FD Resolution No. 12/S-Dearness Allowance/Dearness Relief-54/2017/2898/B. dated 01-11-2019 have sanctioned dearness relief on pension/family pension to their pensioners/family pensioners at the rate from the date as under :

<i>Date of effect</i>	<i>Rate of dearness relief per month</i>
01-07-2019	17% of basic pension/family pension

2. Payment of dearness relief involving fraction of 50 paise and above shall be rounded off to the next rupee and fraction less than 50 paise shall be ignored.
3. Having been authorized by the Principal Accountant General (A&E) Jharkhand in their letter No. PEN-III/Jharkhand/DR/2019-20/2528 (SSA No. 57/19-20) dated 29-11-2019, it is requested to make necessary arrangements for payment of dearness relief @ 17 to all eligible Jharkhand Government pensioners/family pensioners on their pension/family pension with effect from 01-07-2019 after proper adjustment.
4. The charges of this accounts are debitible to the head "8793-I.S.S. A/cs.; Government of Jharkhand etc."
