The Government may consider taking appropriate corrective measures vis-à-vis the issues pointed out in the review and implement the best accounting practices to help increase the efficacy and accuracy of Divisional Accounts.

OVERVIEW

This review has been prepared on the basis of the information collected from the accounting records submitted by Treasuries as well as P.W. Divisions. The previous system of submission of compiled monthly accounts stands discontinued w.e.f 1.4.2015 following changeover of the system of receipts and expenditure of Works Divisions to the CTS package of Treasury under Integrated Financial Management System (IFMS).

Chapter I presents a summary of the total expenditure in Public Works Departments (P. W.) during the year 2018-19.

Chapter II presents an analytical review on the unadjusted balances under P.W. Deposits, P.A.O. Suspense, P.W. Remittances, CSSA, MPSSA and Cash Balance.

Chapter III deals with the amounts placed under objection. No such pending amounts were observed in 2018-19.

Chapter IV gives the information on submission/non-submission of accounting records by the Divisions and deficiencies observed therein.

Chapter V, VI & VII deal with the irregularities noticed by audit during inspection of Divisions.

INTRODUCTION

This is the Annual Review on the working of the Public Works Divisions under different departments of the Government of West Bengal during 2018-19.

Submission of accounting records, adjustment of outstanding balances under Suspense/Remittances Heads of accounts and the outstanding audit observations have been highlighted in the Report.

After the receipts and expenditure of Works Divisions were brought under the Treasury Accounting System running through Computerised Treasury System (CTS) under Integrated Financial Management System (IFMS) with effect from 01 April 2015, instead of Compiled Monthly Works Accounts this office receives copies of treasury vouchers¹, supported by 'Schedule of Works'(Form 64), 'Classified abstract of expenditure' (Form 74), 'Schedule of Deposits'(Form 79), 'Schedule of Deposit Work'(Form 65) and a 'Schedule of Docket' (Form 61) for the purpose of audit work.

The total number of Divisions at the end of the year 2017-18 was 383. During the year under review, the total number of Divisions was 383 (shown in **Annexure I**). Department-wise break-up of the Divisions at the end of March 2019 is given in the table below:

CHAPTER I

Works Accounts at a glance

1.1 Trends of Public Works expenditure against total Expenditure of the State during the period from 2016-17 to 2018-19

The total expenditure of the Works Department during the year 2018-19 was Rs 9,967.38 crore as against Rs 8,260.02 crore in 2017-18 and Rs 6,867.13 crore in 2016-17 representing 5.53, 5.15 and 4.73 per cent respectively of total expenditure of the State Government during that period as given in table below:

2.2 Schedule of Public Works Deposit

2.2.1 Incorporation of Public Work Deposit balance into Treasury system

As per para 16.1.1 of CPWA Code and Note below Rule 267 of the West Bengal Financial Rules Volume I, Deposit Work is a Non – Government Work for which, as per para 16.2.1 of CPWA Code, the local body or other party concerned should advance the gross estimated expenditure payable by it to the Divisional Officer. Similarly, as per Rule 268 of the West Bengal Financial Rules Volume I, Works executed from funds of a Public nature but not included in the financial estimates and accounts of the State is called Deposit work.

Consequent upon discontinuation of LOC system, Finance Department, Government of West Bengal through its memo no. 3292-F(Y) dated 24 April 2015 followed by Memo No.5785-F(Y) dated 29 July 2015, instructed for insertion of the verified positive balance of Deposit Works, Security deposit, and Miscellaneous deposit (*as they stood on 31.03.2015 in Form 79*)u/h **8443-00-108—001- Receipts for P.W. Deposit** as opening balance on 1.4.2015 under three sub-heads viz. **003-Deposit at Treasury for Deposit Works, 004- Security Deposit and 005- Miscellaneous Deposit** subordinate to **Minor Head 108- Public Works Deposit** below the **Major Head 8443- Civil Deposits** in the P W Deposit Accounts to be opened in the Treasury/PAO in favour of the Executive Engineers concerned.

As is evident from the following table, the closing balance under **sub-head 001** has not been migrated to **sub-heads 003, 004 and 005** thereby showing inflated balance under the said sub-head.

2.3 Schedule of Cash Settlement Suspense Account (Old/New)

2.3.1 CSSA (OLD)

In terms of Paras 22.4.10 and 22.4.15 of CPWA Code all inter-divisional transactions awaiting settlement should be collected in Form 76-A posted from division-wise register for submission to the Office of the Pr. Accountant General (A&E), West Bengal alongwith the monthly accounts. Account of such transactions under the head **“8658-00-107 Cash Settlement Suspense Account”** was discontinued in West Bengal from 1 April 1993 vide Government of West Bengal Finance (Audit) Department order No. 12460 dated 18 December 1992.

The accumulated amount under this head has not yet been liquidated as envisaged in the aforesaid Government Order. The total amount outstanding as on 31 March 2019 under this head is Rs.82.27 crores as no documentary evidence for any adjustment have been received from the Divisions during the year 2018-19.

2.3.2 CSSA (NEW)

In terms of para 4(III) of the Finance (Audit) Department order No. 12460-F dated 18 December 1992 a new sub head “Cash Settlement Suspense Account” (CSSA), has been introduced below the minor head **“799-Suspense”** under the relevant Capital or Revenue Major Head with effect from 1 April 1993 in order to book full payment in advance made by the working division to Resources Division for the required material after ascertaining from them about availability and cost thereof by debiting this Suspense head. The debit in this suspense head will be cleared immediately on receipt of materials from Resources division.

On abolition of LOC system, the Resources Division would function as a supplying division to which the Working division would provide advance for bulk procurement of materials necessary for works to be executed by the concerned division. In such cases, the resources division will deposit the advance under PWD Deposit and utilize the advance for procurement of materials. The value of materials procured in excess of Deposit would be adjusted by indenting division by drawing a bill on the Treasury/PAO. This procedure was notified by the Finance department vide para 6 of government order no. 736-F(Y) dated 10 February 2015.

As per schedules under CSSA (New) received from the divisions till 2014-15 the total amount outstanding as on 31 March 2019 under this head is Rs 200.66 crores. The modalities for settlement of this suspense balance have not yet been informed by the State Government.

2.4 Reimbursement of National Highways Expenditure

Funds are allocated for the construction and upkeep of the National Highways in the Union Budget under the Grants for the Ministry of Road Transport & Highways. The execution of the National Highways works is entrusted to the concerned State Government on agency basis. The expenditure incurred on repair/maintenance of National Highway is initially charged to the exchequer of State under the Major head "3054", pending recoupment by the Ministry of Road Transport & Highways, who has Regional Pay & Accounts Offices to oversee the recoupment/reimbursement of expenditure on National Highways work. This entails inter-government transactions between the Central Government and the State Government which are settled through Cash Settlement Procedure by exchange of cheque/drafts. Transactions connected with the maintenance expenditure (and also receipts) on National Highways work occurring in the State P.W. Divisions are initially brought to accounts under State transaction by the Accountant General under head of account '**8658-00-101-148 Pay & Accounts Office Suspense-Items adjustable by Pay & Accounts Office NH**'. This office then transmits the monthly claim statement along with vouchers to the Regional P.A.O. (NH) for reimbursement of claims. The Regional P.A.O. (NH) reimburses the admissible claims and disallows the inadmissible claims. The amount of claim so reimbursed is minus debited under head '**8658-00-101 PAO Suspense**'.

In order to achieve enhanced efficiency and to bring better monitoring and optimum utilization of allocated funds, Direct Payment Procedure (D.P.P.) for execution of National Highways work had been introduced with effect from 1 April 2004 as communicated by the Ministry of Road Transport and Highways, Government of India vide No. PAO/NH/DPP/2003-04/1871-1938 dated 5 January 2004.

During the year 2018-19 an amount of ₹15,42,45,859.00 was disallowed/ withheld by Regional PAO (NH) Kolkata for reasons not on record. Yearwise position of amount disallowed/ withheld on National Highways is shown in **Statement 1**.

2.5 Schedule of Material Purchase Settlement Suspense Account

As per the list of Major Heads of Account of Union and State, the classification "**8658-00-129-MPSSA**" indicates the cost of stores received either by purchase or through Inter Divisional Transfers, the payment of which had not been made in the month of receipt of stores. This implies that the amount outstanding at the end of March 2019 is actually payable by the Government of West Bengal to the Supplier of Stores.

Consequent on the withdrawal of L.O.C. system, operation of suspense head was to be discontinued as per order no 736-F(Y) Dated 10th February 2015. During the period of review, there was no transaction in respect of a number of Engineering Divisions under the control of Public Works Department for more than three complete accounting years under this minor head and no documentary evidence for any adjustment have been received from the Divisions to transfer the unclaimed balances to the credit of revenue as per provisions of Para 13.2.5 and notes there under and Para 15.4.1 of CPWA Code.

2.6 Transactions relating to Head III(b) -Items adjustable by Public Works Divisions

Transactions relating to Public Works Divisions originating in Accounts office are passed on to the Divisions through the Remittance Head “**8782-00-102 Public Works Remittances Head-III(b)**”. These transactions mostly relate to procurement of materials like Cement, Steel, etc. through the Director General, Supplies and Disposals (DGS&D), Department of Supply, Government of India. The existing procedure of purchases made by various administrative departments of State Government against DGS&D rate contracts has been completely stopped with effect from 1 April 1995 vide Government of West Bengal G.O. Nos. 88-F.B. dated 12 January 1995 and 165-F.B. dated 08 February 1995.

Although the Finance Department (Audit Branch), Government of West Bengal was requested to consider writing off of the outstanding balances lying under the Head **8782-00-102-Public Works Remittances Head III(b)** from the Government Accounts, no adjustment have been made so far. As there was no fresh accumulation under this head during the period under review, the total amount of ₹ 4,41,54,96,676.30 at the end of 2018-19 remains to be cleared by the divisions.

Further, through para no. 8(d) of Memorandum No. 736 F(Y) dated 10 February 2015 of Government of West Bengal, Finance Department, Audit Branch, it was stated that outstanding balance under Head–III(b) would be settled as per direction of the Finance Department. Steps need to be taken by the Government to adjust the outstanding amounts.

2.7 Schedule of Reconciliation with Treasury (CTI/CTR)

In terms of Para 22.3.1 of C.P.W.A. Code, P.W.Divisions are required to furnish Form 51 “Schedule of Settlement with Treasury” at the end of each month to the Accounts Office showing details of cheques drawn, cheques encashed and balance of cheques remaining uncashed in Part II duly supported with ‘Certificate of Treasury Issues’ (CTI) and the amount remitted to the Treasuries, amount acknowledged by the Treasuries and balance remaining unacknowledged in Part I, duly supported with Form- 50 Consolidated Treasury Receipts (CTR) provided by the Treasury Officer.

However, it has been observed that reconciliation is not being carried out by the divisions with the treasuries. After the introduction of Treasury System from 1 April, 2015, the Divisions are not required to submit CTIs / CTRs but **they continue to be responsible for adjusting the outstanding CTIs/ CTRs related to past works accounts upto 31.03.2015 as per Memorandum No. 736 F(Y) dated 10 February 2015 of Government of West Bengal, Finance Department, Audit Branch.** Period from which Schedule of Settlement with Treasury (SSWT) has not been furnished by each division is detailed in **Statement 2.**

2.8 Stock

In terms of Para 13.3 of CPWA Code, the head “Stock” was opened in all divisions where stock of materials was maintained for general purposes vide paragraph 143 of the Central Public Works Department Code.

The account head “Stock” was debited with all expenditure connected with the acquisition of stock materials and with all manufacture operations. It was credited with the value of materials issued to works, or sold, transferred or otherwise disposed of, and the balance of account would represent the book value of the materials in stock plus the unadjusted charges, etc., connected with manufacture.

The general account of the receipts, issues and balances of the suspense head “Stock” should be maintained in the Suspense Register, Form 67. A separate account should be kept in respect of each sub-head, the transactions of the several sub-divisions being detailed therein as separate items and the totals of all sub-divisions as another. Transfer within the division should be accounted for against a single item “ Deduct Transfers within Division” before the total for the entire head “Stock” was struck.

Consequent upon the withdrawal of L.O.C. system and introduction of IFMS w.e.f 1 April 2015, the process of adjustment of outstanding balance (in pre-IFMS period) under “Stock” has been depicted under Para 29 of Memorandum No. 2705-F(Y) dated 30 March, 2015 of Government of West Bengal, Finance Department, Audit Branch, but no adjustment or action in this regard has been acknowledged by this office during the period of review. An illustrative list of Divisions holding stock as on 31.03.2015 is shown in **Annexure VI**.

CHAPTER III
Amounts held under objection

3.1 Objection Book

Since all the vouchers and challans of Divisional Officers are being routed through Treasury Accounting System w.e.f. 1 April 2015, no vouchers are kept under Objection Book at the end of March 2019.

CHAPTER IV

Promptness in submission of Accounts

4.1 Rendition of Vouchers and Forms

The Divisional Officer, as the primary Disbursing Officer of the Division is responsible not only for the financial regularity of the transactions of the whole Division but also for the maintenance of the accounts of the transactions correctly and in accordance with the rules in force vide Para 4.1.1 of C.P.W.A. Code.

4.2 Non submission of Accounting Records and vouchers

The Monthly Accounts are due for submission in the Office of the Pr. Accountant General (A&E), West Bengal by 10th of the following month to which they relate. But no Division could adhere to the time schedule during 2018-19. Out of 383 divisions, 51 divisions did not render the accounting records and vouchers either for months together or the whole year. Detailed information on non-submission in this regard is given in **Statement 3**.

4.3 Irregularities noticed in Accounting Records

Omission and other defects during submission of voucher and requisite CPWA Forms are shown in the **Statement 4**. The matter is being pursued through observations issued against such Divisions as and when submitted to this office.

7.6 Non maintenance of Measurement Books

As per paragraph 10.2.7 of C.P.W.A. code Payments for all work done otherwise than by daily labour and for all supplies required for specific works are made in a division are on the basis of measurements recorded in measurement books.
