Subject: Release of Financial Incentive under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the state of Assam for the year 2018-19-reg.

Sir,

- 1.1 I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to Rs.36,18,00,000 /- (Rupees Thirty Six Crore Eighteen Lakh only) to the State of Assam for "Financial Incentive" as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2018-19.
- 1.2 These funds are exclusively meant for periodic maintenance of roads already constructed under Pradhan Mantri Gram Sadak Yojana.
- 1.3. The State Government must transfer these funds to Assam State Road Board (ASRB), Guwahati within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

- 1.4 Assam State Roads Board (ASRB) has nominated **Shri Dibyajyoti Saharia, Chief Engineer**, PWD (Roads), Government of Assam, Chandmari, Guwahati -781003 as the Empowered Officer.
- 1.5. The funds transferred by the State Government to ASRB shall be kept in a separate Saving Bank Account No.10566991446 (IFSC Branch Code No. SBIN0000221), State Bank of India, New Guwahati Branch, Guwahati-781021. It shall be ensured by ASRB that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of periodic maintenance of rural roads already constructed under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officers of ASRB shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's said Bank Account for the purpose of this sanction.
- 1.6. The State Governments are requested to credit matching State Share against the funds released vide this letter in respective ASRB's accounts as per PMGSY guidelines and update the status on OMMAS.
- 1.7. The Empowered officer shall issue standing instructions to the Bank regarding the names of Authorised Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payment as per the agreed work programme for the respective package.

- **1.8.** No Utilization Certificate is pending from the agencies indicated in column 4 of table in para 1.2 above.
- 1.9. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules (GFR).
- 1.10. The expenditure is debitable to the following Head of Account under **Demand No. 82** of the Department of Rural Development during the current financial year 2018-19:-
