Subject: Release of Financial Incentive under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State of Haryana for the year 2018-19-reg.

Sir,

1.1 I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 13,20,00,000/- (Rupees Thirteen Crore Twenty Lakh only)** to the State of Haryana for "**Financial Incentive**" as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2018-19**.

1.2 These funds are exclusively meant for periodic maintenance of roads already constructed under Pradhan Mantri Gram Sadak Yojana.

1.3. The State Government must transfer these funds to Haryana Rural Roads & Infrastructure Development Agency (HaRRIDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

1.4. The funds transferred by the State Government to HaRRIDA shall be kept in a separate **Saving Bank Account No. 65038038336 (IFSC Code No. SBIN0050202) in State Bank of India, Sector-7-C, Chandigarh.** It shall be ensured by SRRDAs that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of periodic maintenance of rural roads already constructed under the Pradhan Mantri Gram Sadak Yojana. Haryana Rural Roads & Infrastructure Development Agency (HaRRIDA) has nominated **Shri Varun Gupta Executive Engineer, HaRRIDA, PMGSY** as the Empowered Officer.

1.5. The State Governments are requested to credit matching State Share against the funds released vide this letter in respective SRRDA's accounts as per PMGSY guidelines and update the status on OMMAS.

1.6. The Empowered officer shall issue standing instructions to the Bank regarding the names of Authorised Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payment as per the agreed work programme for the respective package.

1.7. No Utilization Certificate is pending from the agencies indicated in column 4 of table in para 1.2 above.

1.8. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules (GFR).

1.9. The expenditure is debitable to the following Head of Account under **Demand No. 82** of the Department of Rural Development during the current financial year **2018-19**:-

- 3601 - Grants-in-aid to State Government (Major Head)
- 06 - Centrally Sponsored Schemes
- 101 - Central Assistance Share
- 30 - Pradhan Mantri Gram Sadak Yojana
- 30.01 - Program Component-PMGSY
- 30.01.35 - Grants for creation of capital assets

1.10. The Assistant Director, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Government of Himachal Pradesh.
