Minutes of the Meeting of Pre-EC held on 7th October, 2013 for the proposals of the State of Odisha under PMGSY

A Meeting of Pre-Empowered Committee for PMGSY was held under the Chairmanship of Joint Secretary (RD) in his chamber on 7th October, 2013 at 11,00 AM to discuss the proposals sent by the State of Odisha for the new connectivity under Regular PMGSY and ADB RCIP Tr-III. 2. Director (Tech.) presented the proposal sent by the State as under:-

3. Habitations details on OMMAS:

3.1 The Director (Tech) presented the status of eligible unconnected habitations under the Scheme as below:

- 3.2 The JS(RC) asked the Dir(Tech) to prepare the above status bifurcating in two categories i.e. 250+ ineligible and 250+ eligible under PMOSY.
- 3.3 The State informed that there are about 1.414 habitations to be added to the CN-IV as per the Cabinet decision. Out of these habitations, about 100 habitations are in the category of "left out habitations" and remaining habitations have been "wrongly shown as connected". JS(RC) asked the Director(Tech) to put up the consolidated status of habitations being claimed by the States as having been shown as wrongly connected in the Core Networks for all the States to obtain the view of the Ministry in this regard.
- 3.4 JS(RC) also asked Dir(Tech) to prepare a brief note and PPT slides clearly bringing out the relevant clauses of Cabinet decision regarding inclusion of left out habitations in the Core Network in the subsequent EC meeting for the State of Odisha.
- 3.5 The JS(RC) asked the State to update the status on OMMAS in consultation with Director (Tech) and send the reconciled details duly tallied with OMMAS before sending brief for EC. He also emphasised the need to conduct a sample verification of the aforesaid 1414 habitations. In IAP districts the sample verification should focus on left out habitations.

4. Balance length to be cleared to complete new connectivity as per PMGSY guidelines in the State:

The State informed that excluding the present proposal, the proposal of balance length of about 13,500 km under new connectivity and about 7,500 km under upgradation is yet to be sent by the State for clearance.

5. Updating Proposal and Progress Modules on OMMAS:

The JS(RC) asked the State to update the Proposal and Progress Modules on OMMAS on a priority basis and send the MPR as per OMMAS data alongwith the brief of EC. (17 habitations not mapped on OMMAS would also be mapped by the State in consultation with NRRDA).

6. Completion Plan:

The JS(RC) observed that the actual achievement by the State is substantially lower compared to completion plan sent by the State in Aug. 2012 and asked the State to send realistic

month-wise completion plan alongwith brief for EC, and to expedite completions as per the revised monthly targets without compromising on quality.

7. Verification of Bridge estimates by the Chief Engineer/SEs:

The JS(RC) advised the State that all the bridge DPRs should be verified by the CE/SE and they should suggest if any improvement or corrections are required to the PIUs.

Dir(Tech) asked the State to send the design details of the bridges and the joint site inspection report of STAs and SEs.

8. Dropping of roads:

The JS(RC) asked the State to send all cases of dropping to NRRDA and attach the Statement with brief for EC. NRRDA should quickly analyse all such cases and send its recommendations to the Ministry.

9. Compliance of DPR issues:

Director (Tech) brought out some issues with regard to DPRs sent by the State (Annexure-I). The JS(RC) asked the State to comply with the observations before sending brief for EC.

10. Implementation and executional capacity of the State:

10.1 The Dir(P-I) presented the capacity of the State as under:

- 10.2 As informed by Dir(P-I), the current capacity of the State to handle the work load is Rs. 3.125 erore. The State is already having projects work load of Rs.6,120 erore in hand to be completed. Hence to execute additional projects it requires to enhance its implementation capacity on an urgent basis.
- 10.3 The JS(RC) asked the State to send the PIU-wise work-load after considering the present proposal and its strategy to handle the workload efficiently. What is required immediately is-
 - Increase in the number of PIUs.
 - a decision on induction of Central PSUs as additional PIUs
 - strengthening of present PIUs
 - Contractor outreach programmes to resolve their problems and strengthen them.

10.4 The Dir(YSD) asked the State to send the PIU-wise strength of the technical staff (No. of SEs/EEs/AEs/JEs) and workload being handled by them including works sanctioned by the State

11. Bifurcation of Proposal into ADB and Regular PMGSY category:

The JS(RC) asked the State to bifurcate the proposal so as to consider about 1,000 km under ADB. (State to earmark the districts and the PIUs handling these 1000 km of road works).

12. Provision of Cement Concrete Pavements:

Dir(Tech) informed that it appears that the State has taken the Cement Concrete Pavement length in excess of the requirements, in the DPRs.

The JS(RC) asked the State to consider the CC Pavement as per the actual requirements in the DPRs.

13. Proposals under R&D /Use of marginal materials/New technology:

The State informed that it has considered about 100 roads using cold mix technology, toller compacted concrete, usage of fly ash/ steel slag in the present proposal.

14. Quality assurance by the State:

Dir (P-III) brought out the fact that the quality assurance by the State is in an unsatisfactory status. As per PMGSY guide ines, each work should be inspected at least three times by the SQMs but on average it is being inspected only once. Though the State has engaged 35 SQMs, they are not being fully utilised, hance there is a need to ensure effective deployment of SQMs. The status of inspections is enclosed as Annexure-II

During the financial years 2011-12 to 2013-14, the NQMs have reported Unsatisfactory works of 9% and 25% respectively for completed and ongoing works inspected by them which is on the high side. (Annexure-III).

The JS(RC) asked the State to send the SQM inspection programme for the works in hand and its plan to institutionalise the second tier quality monitoring.

15. Finance and accounts issues:

Director (F&A) brought out the accounts issues. The State agreed to address these issues and send status along with the brief for EC.

16. Final Bill payments and financial closure of projects:

The State also agreed to concentrate on the clearance of 978 nos. pending Final bills of the contractors and financially close the works on the OMMAS.

17. Compliance status of issues in Clearance letter dated 23rd Aug, 2013

The JS(RC) asked the State to send the Status of compliance of issues in Clearance letter dated 23rd Aug, 2013 alongwith the brief for EC.
