Subject: Release of Balance amount of Financial Incentive for the year 2018-19 under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State of Madhya Pradesh

Sir,

1.1 I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.30,00,00,000/- (Rupees Thirty Crore only)** to the State of Madhya Pradesh for **"Financial Incentive"** as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2018-19.**

1.2 These funds are exclusively meant for periodic maintenance of roads already constructed under PMGSY.

1.3 The State Government must transfer these funds to **Madhya Pradesh Rural Road Development Authority (MPRRDA)** within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

1.4 The funds transferred by the State Government to MPRRDA shall be kept in a separate **saving Bank Account No. 1793139758 in Central Bank of India (IFSC Code-CBIN0283312), 9 Arera Hills Branch, Bhopal, Madhya Pradesh.** It shall be ensured by **Madhya Pradesh Rural Roads Development Authority (MPRRDA)** that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the **Madhya Pradesh Rural Roads Development Authority (MPRRDA)** shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

1.5 The State Governments are requested to credit matching State Share against the funds released vide this letter in respective SRRDA's accounts as per PMGSY guidelines and update the status on OMMAS.

1.6 **Madhya Pradesh Rural Roads Development Authority (MPRRDA)** has nominated **Shri M. P. Singh Niranjana, Chief General Manager (Finance), MPRRDA** as the Empowered Officer.

1.7 No Utilization Certificate is pending from MPRRDA.


1.10. **Secretariat of the Election Commission of India, New Delhi has stated that release of financial incentives under PMGSY would be subject to following conditions:-**

- (i) There shall be no publicity in this regard in electronic, print, radio, internet or any other media, in any form whatsoever.
- (ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
- (iii) These restrictions on publicity will be applicable to the Central Government as well as State Governments concerned.
- (iv) The relevant provisions of Model Code of Conduct (MCC) issued by the Commission shall be strictly followed.
- (v) No new work shall be taken up afresh during MCC period.

1.11 The Assistant Director, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Government of Madhya Pradesh.

1.12. This issues under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their **U.O. No.1411/Finance/2018-19, dated 25.03.2019**


