The matter of scrutiny and locking of the proposal by the STA was examined in the Pre-EC meeting and the following observations were made:

- The State of Uttarakhand has two STAs (IIT ROorkee and Engineering college Pantnagar). The state has to demarcate / allocate districts to the two STA as has been directed earlier by the Ministry under intimation within a week.
- ii. The present STA, i.e IIT Roorkee, as informed by the Chief Engineer of the state has scrutinized the DPRsin question but not loaded on OMMAS. The state government should ensure that the DPRs are properly scrutinized, uploaded and locked by the STA, by coming Monday i.e 10 th of April 2017.
- iii. Once the DPRs are scrutinized and locked by the STA, NRRDA would generate the list of DPRs and seek physical copies of the DPRs from the state for sample scrutiny.
- After receipt of above compliance, date of EC would be sought in the second week of May
 2017 from the office of Secretary (RD).

The meeting ended with a vote of thanks to the Chair.
