**3. Recommendations of the Committee:**

**After due deliberations, it was decided that the State will complete following activities as agreed to by the State before the EC Meeting.**

- i. **The Joint Inspection Report in respect of all 509 LSBs should be sent;**
  - ii. **The State should submit the sample DPRs as identified by NRRDA;**
  - iii. **The States should identify and upload the roads proposed under ADB of PMGSY on OMMAS;**
  - iv. **The DPRs where the average cost is more than that of Batch-II proposal of 2017-18 need to be further scrutinized based on the suggestions given by the team of NQMs, who have recently visited the State to scrutinize the Batch-II proposals.**
4. The State should send a compliance report to the Ministry on all issues as indicated at **para 3 above within two weeks so as to enable the Ministry to fix the EC Meeting.**
5. The meeting ended with Vote of Thanks to the Chair.
