Discussions held and Decisions taken:

- It was seen that all the roads proposed in the current Batch has been approved by MHA
 except the Sambhalpur to Durgkondal Package No.CG08014 does not figure in the MHA
 list. The Committee took the decision that the road would be taken up subject to
 approval of the MHA.
- The maintenance costs proposed by the State for 5 year routine maintenance and 6th year renewal cost are too less and should be atleast 10% and 18-25%.
- The State has not proposed any length on R&D proposals. They were directed to propose the requisite 15%.
- With respect to DPR Issues the following were flagged
- Quantity of Bituminous macadam (BM) needs to be deducted from CD length portion.
- Design drawing of protection work is not attached in DPR.
- No detailed soil investigation report is available without which selection of suitable foundation of LSB is not possible.
- No other major issues, State has complied the observations communicated to them.
- Dir (Technical) was directed to present Data on SQM inspections on the RCPLWE roads during the Empowered Committee and start NQM Inspections on these roads.
