The following emerged during the course of discussions

1. While habitation data entry for PMGSY –II has been completed on OMMAS, the DRRP for PMGSY-II have not been uploaded on OMMAS. The original data of PMGSY-I has not been ported by the C-DAC due to which the state has been unable to make the necessary corrections and updation in DRRP.
2. The Pre EC meeting ,therefore, was deferred and the state was asked to commit a date for the Pre-EC by which it will have to ensure the uploading of DRRPs on OMMAS and the scrutiny of the DPRs by the STAs.
3. The Pre EC meeting would be reconvened on 25th April, 3pm as suggested by the State.
