### 3. The following issues were discussed during the meeting:

- i. The State was asked to reconcile the data of balance unconnected habitations on OMMAS before the Empowered Committee meeting.
- ii. The State requested for inclusion of 2 more bridges later as they were very essential for providing connectivity. The Committee decided that the request would be put before the Empowered Committee Meeting for discussions.
- iii. Most of the DPR observations raised by NRIDA have been complied by the state. However state was asked to justify the higher traffic requirements through third party traffic surveys.
- iv. State has put up a request for provision fund for restoration of damages on ongoing works due to the heavy rains.
- v. It was seen that there were 120 works in which payments of more than 1 crore had been made without any SQM inspection.
- vi. State was asked to make improvements in the quality aspect of maintenance works.
- vii. State requested for an extension of one more month for liquidating the final bills of completed works within 6 months as this process had been affected to a great extent by the issues in PFMS. State was asked to send a request.
- viii. State committed to send the demand for second installment of programme funds by 12<sup>th</sup> of October.
