**The State Government representative intimated that the State will not send any upgradation proposal under PMGSY-I for the balance length.**

**3. Habitation Connectivity Status**

The State representative intimated that DPRs for 165 more habitations (final batch) have been prepared and will be submitted shortly. The State was asked to reconcile the habitation on OMMAS by the end of this Month.

**4. Recommendation of the Committee**

The State Government has not yet submitted sample DPRs to NRIDA for scrutiny. In the absence of the same, the NRIDA was not in position to offer its comments/observations specific to the proposal. Therefore, the Committee decided to defer its observations/recommendation and asked the State submit sample DPRs for the entire 294 habitations so that the same could be scrutinized NRIDA and considered by the Pre-Empowered Committee thereafter at an early date.
