# MINUTES OF THE PRE-EMPOWERED COMMITTEE MEETING HELD ON 20<sup>TH</sup> JANAUARY, 2020 TO CONSIDER PROJECT PROPOSALS SUBMITTED BY THE GOVERNMENT OF MAHARASHTRA UNDER ROAD CONNECTIVITY PROJECT FOR LEFT WING EXTREMISM AREAS (RCPLWEA) (BATCH-I, 2019-20)

#### Out of 35 proposals of roads-

- 14 roads of 30.99 km length having 3.0 m carriageway, Avg cost Rs 84.41 lakh/km
- 19 roads of 321.65 km length having 3.75 m carriageway, Avg cost Rs 149.64 lakh/km
- 02 roads of 91.17 km length having 5.5 m carriageway, Avg cost Rs 122.16 lakh/km

## ISSUES DISCUSSED AND DECISIONS TAKEN

#### 1. Observations regarding cost:-

- (i) The Average cost of 19 Roads of 321.65 Km length having 3.75 m carriageway is Rs.149.64 lakh/km and when it compared to 2017-18 (RCPLWE (3.75m) of Rs.88.61 lakhs/km which is exorbitant. The rate calculated on the basis of DSR of MMGSY was not accepted. The State is advised to re calculate the rates on the basis of PMGSY DSR rates of 16-17.
- (ii) The 20% escalation in cost has been considered in rate analysis for LWE, which need to be deleted or else the State has to bear the additional cost on this score.

#### 2. General DPR Observation:-

- i. Average cost/km of roads seem to be on the higher side.
- ii. Provision of Modified Penetration Macadam (MPM)/BM has been provided in some of the DPRs even though the traffic is in the order of T4 to T7.
- iii. DPRs have not prepared as per the standard DPR templates issued by NRIDA. The required detailing and chapters are not attached with the DPRs.
- iv. Quantity of pavement materials in RCC Culverts/Minor Brides portion should be deducted from total pavement material quantity estimates.
- v. Drains has been proposed invariably without drainage plan indicating direction of flow, location of outfalls etc and proper design based on magnitude and duration of flow.
- vi. Tack coat has been proposed twice even though 50mm BM has been adopted in the DPRs
- vii. The average cost towards CDs/Protection works in many of the DPRs appears to be in higher side, which need re-examination.
- viii. Cost per km of DPR preparation should be considered as per NRIDA norms.
  - ix. 20% escalation in cost has been considered in rate analysis for LWE, which need to be deleted or else the State has to bear the additional cost on this score.
  - x. 5% for escalation has been considered over the DSR of 2018-19 (MMGSY) for increase in the rates in 2019-20 without vetting from NRIDA.
- xi. Proper justification needs to be given for the Royalty charges considered.
- xii. 2 roads proposed using T9 traffic category. State need to provide 3 party traffic verification statement.
- xiii. Bridge designs are not based on latest code. Needs to be revised using latest IRC codes.
- xiv. Joint Inspection report of Bridges site needs to be provided.

#### Maintenance:-

The State has proposed Rs.3,934.38 lakhs for 5 years Routine Maintenance cost which is 6.36% with reference to cost of construction and the same can be agreed to. However, 6<sup>th</sup> year renewal cost is lower side at 5.11% which needs to increased to 18% to 20%.

#### **R&D** Technology:-

The State has proposed a length of 34.93 km road using Waste Plastic a Technology with IRC Accreditation. However, the state has not proposed adequate length using new technologies as per New Technology initiative guidelines viz. 10% Technology with IRC Specification (Main Streaming of Technology and j5% Technology with IRC Accreditation. The State should recheck their proposal and propose accordingly.

### Ommas Updation:-

The State is advise to update their awarded works of Roads and LSBs in ommas immediately. The entry made funds received by SRRDA from GOI may be corrected which was included the State Share also.

#### Quality Issues:

There are 27 packages and no labs has been established. The SQC is to be finalized the lab. No SQM inspection were carried out. The state is advised to approved the SQM since there a number of SQMs are available as there is limited number of PMGSY works are in progress.

#### Recommendations of the Committee:-

The Average cost indicated on the basis of DSR (MMGSY) are exorbitant, the state may re-check the average cost with reference to PMGSY rate of 16-17 or earlier PMGSY rates and arrive the cost. Also send the comments on all DPR observations and revise the cost as discussed in the Pre-EC meeting within ten days so that the EC meeting can be considered on 4<sup>th</sup> February, 2020.
