



The State requested for the inclusion of 1 bridge (129 mt) which had incurred heavy damage in lieu of 1 bridge not considered due to submergence of road due to construction of dam. State was asked to submit the details of the damaged bridge for examination. **(Action: MPRRDA)**

3. Of the remaining 96 habitations on OMMAS 67 habitations are non-feasible on OMMAS. The list of 96 unconnected habitations is to be given to the State was directed to examine the list and identify the habitations already connected under State scheme and habitations that are non feasible within 1 week. **(Action : CDAC and MPRRDA)**

4. The average cost proposed were agreed to by the Committee.

5. **Issues discussed and decisions taken:**

- The State was asked to review the DPRs of Bridge Across SIP River on Chhapri to Baisaad Road, Block Nasrullaganj, Sheore (MP) & Bridge Across Nalla on Kumantal to Hamidganj Road, Chainage 2000, Block Nasrullaganj, Sheore (MP) Bridge Across Ghodapachhad River on Padlya to Hasanpura Road, Block Khalwa, Khandwa (MP) **(Action: MPRRDA)**.
- Balance sheet for maintenance funds 2017-18 has not been submitted by the State. **(Action: MPRRDA)**
- E-marg information has to be integrated to OMMAS. The login id MP E-Marg is to be given for the same to Pankaj for porting the data. **(Action: MPRRDA and CDAC)**
- 414 bills of closed works are still shown as pending for final payment. The State brought to the notice of the Committee that most of the bills are packages where single road is pending completion. CDAC was asked to work on Package-wise and road-wise pendency in the format. **(Action: MPRRDA and CDAC)**
