

It was brought to the notice of the Pre-EC Committee that no proposal has been uploaded on OMMAS till now.

General Issues

- A 1 eligible unconnected habitations including 49 left out habitations from the original Core Network and 125 wrongly located habitations in CNW have already been sanctioned.
- At the time of considering 174 above said habitations State has repeatedly asked about balance 391 habitations about their wrongly reported locations. However, State has confirmed that their location is correct.
- Now the State has reported 396 left out / wrongly shown habitations are in different groups.
- Geotagged photographs for 396 Left out habitations/ wrongly shown habitations have not been provided for verification.
- File was being submitted to Ministry for Considering 407 wrongly shown habitations under Upgradation which was under process at the time of Pre-EC. Now the file has been approved however, **at the time of EC state should provide geo-tagged photographs of roads proposed, and duly verified by STAs, so that the cost remains confined to that of up-gradation and not new connectivity.**

- Proposal is yet to be verified. Soft copy of cost estimates for 4 roads have been received on 10.01.2018.
- Average cost per Km of Up-gradation works should have a minimum difference of Rs. 5 to 7 lakhs/Km from NC average cost.
- State has not uploaded and scrutinized by STA on OMMAS.
- It was communicated to the state that proposals **scrutinized by STA on the date of Pre EC will only be considered by EC for recommendation.**

Maintenance Issues

- Maintenance cost proposed is 5.51%; The Committee was of the opinion that Maintenance cost is on lower side. It should be more than 7% for M P State in view of providing hard shoulders.
