4. General and DPR Issues:

- State was asked to reconcile the data regarding balance unconnected habitations on OMMAS.
- MP-I, MP-II, MP-III and copy of SLSC approval needs to be provided.
- For fixing the deck level of SUMERSIBLE bridge, Clause 5.1.2 of IRC SP:82-2008 should be satisfied.
- GAD, structural drawings and other drawings are not compatible/matching with each other. The drawings should be rechecked and corrected.
- Joint Inspection formats for bridge works have not been received.

5. Maintenance issues:

- State has proposed maintenance cost of 3.12 % which was agreed to by the EC.

6. Quality Issues:

- It was observed that 92 cases of payments of more than 1 lakh had been made before inspection of works by SQMs even once.
- It was observed that the works of 107 contractors were not inspected by NQMs even once.
- 2 ATRs of completed works and 41 ATRs of ongoing works are pending with the state.

7. Financial and Accounts issues:

- State has 262 pending final bills which are to be liquidated on a priority basis.
