

- 3 Jt. Dir (Tech.) brought out that the reconciled details of PMGSY benefitted habitations should be corrected on OMMAS and data should match with OMMAS
- 4. Jt. Dir (Tech.) informed that the State has entered the proposals for 177 roads and 7 bridges as per cost of Rs.282.43 Cr. on OMMAS duly scrutinised by STA under regular PMGSY(Batch-III) and another proposal of 48 LSBs of cost of Rs.53.90 Cr. as on 22.10.2017. A difference has been observed between data presented by the State Govt. and on OMMAS and the State representative directed to that the scrutiny of all such proposals may be done by STAs before submitting them to the Ministry/NRRDA.
- 5. In the matter of bridges, State stated that due to rainy season foundation exploration is not possible. Hence, DPRs were not ready. Now DPRs proposals has started for all 136 left out bridges (more than 60 mtr length) will be sent separately to Ministry/NRRDA for consideration.
- 6. It was brought to the notice that the average cost in respect of districts Hoshangabad, Dewas, Indore, Burhanpur and Khargone is very high. State Govt. was advised to use new technology for construction of roads. State Govt. was also advised to update their data on which was wrongly entered.
- 7. The State representative stated that the reason for increase of average cost is due to higher cost of CD works which falls under Narmada area. The State has also agreed to use new technology to rationalize the average cost.

Recommendations:

The Committee recommended the proposal of State Government of Madhya Pradesh for construction of 177 roads of new connectivity and 7 bridges at a cost of 282.43 crores (MoRD share: Rs.162.57 Crores and State share: Rs.119.86 Crores) with a total length of 492.20 kms of roads and 227.40 mts of bridges.
