2. General and DPR issues of the proposals of road-works:

 While it was seen that the average costs have been reduced after scrutiny of DPRs; the average cost/Km is on higher side when compared to previous sanctions (Both the roads are 3.75 m carriageway width).

3. Maintenance issues

 Maintenance cost (5 Year) of 5.50% and Maintenance cost (Renewal) of 15.10% with respect to construction cost was proposed, which was agreed upon.

4. R&D proposal & R&D Technology:

 The state proposed 48.65 km roads using waste plastic. This was highly appreciated in the meeting.

5. Miscellaneous issues

- It was seen that all roads and bridges have been uploaded on OMMAS as well as scrutinized by the STAs. However Proposals entered in Batch II of RCPLWE needs to be shifted to Batch I of RCPLWE by the State.
- The State raised the issue of implication of GST on PMGSY works; a request was made for accommodating the extra tax burden within the costs for which the state would also contribute its matching 40% share. It was decided that the State would send a comprehensive note for examination by the Internal Finance Division of the Ministry.
