



**MINUTES OF THE MEETING OF THE PRE-EMPOWERED COMMITTEE FOR
PMGSY HELD ON 14 NOVEMBER 2017**

STATE: TELANGANA

A Meeting of the Pre- Empowered Committee was held under the chairmanship of JS (RC), MoRD on 14th November 2017 at 11.30 am to discuss the proposals under RCPLWE of PMGSY submitted by the State of Telangana. List of participants is given below:

2. Details of proposals discussed by the Committee for the State of Telangana are as under:

3. Issues discussed and Action Emerged

The proposals were discussed in detail and the following emerged.

- i. Total scope of RCPLWE for R&B Department in Telangana is 23 roads and 3 LSBs. The State representative informed that out of 23 roads as approved by MHA, 3 roads have already been constructed under State Scheme and are being substituted with other 3 roads.

- ii. The State was advised to submit sample DPRs to NRRDA for scrutiny;
- iii. The State representative informed that there are certain bridge works (span of more than 15 mtr) on these 12 proposed roads, for which DPRs are being prepared. The State was accordingly advised to submit the DPRs of LSBs along with road DPRs;
- iv. For Roads proposed with 7 m carriageway width, the additional cost beyond 5.50 m width should be met from State share as per RCPLWE guidelines;
- v. The State should propose some roads with any Technology with IRC specification like cold mix, Waste plastic etc.
- vi. The construction cost appears to be on higher side compared to the rate sanctioned for other States under PMGSY; The State needs to relook all DPRs.
- vii. NRRDA would advise the STAs concerned to scrutinize the proposals submitted by R&B Department on priority basis;
- viii. The State should submit the DPRs of all roads and LSBs by 15th December 2017.

4. Recommendations of the Committee:

After due deliberations, it was decided that the State will submit composite Proposals (Batch-I) as per above by 30th November 2017 and a Pre-EC Meeting for Batch-I would be reconvened in the first week of December 2017.
