General Issues

The Committee was informed that the State of Telangana has already been sanctioned 20 road works and 18 LSB's measuring length 451.37 Km under RCPLWEA Phase I. Further, the Ministry of Home Affairs has recommended 74 additional Roads and 5 Bridges/culverts measuring length 743.31 Km for the State. The State Representative intimated that out of 74 road works &5 bridges/culverts, the current batch of proposal is for 40 road works and 16 LSBs measuring 253.84 Km. The balance 34 road works are not feasible.

- 2. On scrutiny of proposals for 40 road works & 16 LSBs (253.84 Km and 915.76 Meters) at a cost of Rs. 348.57 crore (average cost Rs. 111.52 Lakhs and Rs.7.15 Lakhs per meter respectively), the Committee observed that the average cost/Km is exorbitantly high. Out of 40 roads, 18 road has been proposed with 3.75 M (T7), 21 Roads proposed with 5.50M and 1 Road have been proposed with 7 M carriageway width.
- 3. On perusal of the Average Cost including 10% Price Adjustment & Tender Premum, it was observed that the cost is high a all the proposals are for constructions of new roads, also they pass through the forest areas where mining activities are not allowed and the lead is far away. State Government was asked to give a certification in all such cases. The State Government representative informed that the rate has been calculated on the basis of the SoR 2019-20 of the State. The State was asked to re-look into the proposal and revise the proposal as per the observations of the Committee.
- 4. It was also decided to depute some NQM to inspect one or two roads out of the list to check the reasons fpr calculations of such high cost.

5. **DPR Issues:**-

- (i) The State should certify that the proposed alignments are as per the road alignments approved by MHA.
- (ii) Transect walk photographs to be attached with the DPR
- (iii) The Earthwork cost is on the higher side particulary in Kumarambheem Asifabad district. It needs rationalized.
- (iv) State needs to ensure that the required land width is available to provide 9 m top width for 5.5m carriageway width roads as per IRC guidelines for 5.50 and existing CDs also widened to 9m.
- (v) Hydraulic details, catchment area calculation, hydraulic adequacy of proposed and existing CDs are to be provided in the DPR.
- (vi) Drains proposed in open areas needs to rationalized.

- (vii) State should ensure that QC charges and LS provisions made in the DPRs have been deleted in all the DPRs.
- · (viii) Joint Inspection formats for bridge works (STA and SE or SE and CE to be submitted fully.

Maintenance issue

- 6. The Committee observed that the Maintenance cost for 5 years indicated is 5.61% w.r.t cost of construction is very low and it should have to 6 to 6.5% of the cost of construction. Similarly, the 6th year renewal cost for maintenance should be 20% instead of 16.59% indicated.
- 7. The State was also advised to increase the number of SQMs.

R&D issues

8. The State has not proposed any roads using New Technologies whereas 15% of length needs to be proposed using new technology as per Technology initiative guidelines.

Contract management

State was asked to award all pending works which has remained un-awarded.

Finance and Accounts

State share has not been released.

Recommendation of the Committee

- 6. Taking into consideration of the higher costs projection, it was directed to verify the rates with latest SoR of MoPR. A team of NRIDA will visit one or two roads to ascertain the reason for increase of material cost and also earthwork cost. The State was asked to revise the proposal as per the observations of the Pre-EC and re-submit the revised proposals by 11th November, 2019 so that the same could be placed before Pre-EC/EC for further consideration.
- 7. The meeting ended with Vote of Thanks to and from the Chair.
