I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to Rs. 98,00,000 (Rupees Ninety Eight Lakh only) as 1st installment of Central assistance towards Administrative Fund under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State Government of Tripura for the Financial Year 2019-20.

2. The State Government must transfer these funds to Tripura Rural Road Development Agency (TRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may consider to stop further releases. - 3. Tripura Rural Road Development Agency (TRRDA) has nominated Er. Alakes Sengupta, Chief Engineer as the Empowered Officer.
- 4. The funds transferred by the State Government to TRRDA shall be kept in a separate Saving Bank Account No. 10221183205 in State Bank of India, (IFSC Branch Code No. SBIN0004545), State Bank of India, Kunjavan, Agartala, Tripura.
- 5. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 6. The TRRDA shall utilize the amount released under Administrative Fund as per revised paral 2.2 of the programme guidelines issued vide this Ministry's Circular No.P-12014/1/2014-RC dated 20.5.2014.
- 7. No Utilization Certificate is pending from Tripura Rural Road Development Agency (TRRDA).
- 8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

- 9. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the O/o the CCA of the Ministry in terms of Rule 211 (1) of the General Financial Rules.
- 10. The expenditure is debitable to the following Head of Account under **Demand No.- 84** Department of Rural Development during the current financial year (2019-20):-
