I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to Rs.1,45,89,000 (Rupees One Crore Forty Five Lakh Eighty Nine Thousand only) towards 1st Installment of Administrative Funds to the State Government of Andhra Pradesh under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2018-19.

- 6. No Utilization Certificate is pending from Andhra Pradesh State Rural Roads Development Agency (APSRRDA).
- 7. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.
