Subject –Release of Administrative Fund to the State Government of Andhra Pradesh under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2018-19.

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs.3,04,11,000 (Rupees Three Crore Four Lakh Eighty Eleven Thousand only)** towards 2nd Installment of Administrative Funds to the State Government of Andhra Pradesh under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2018-19.

1.2. **The State Government must transfer these funds to Andhra Pradesh State Rural Roads Development Agency (APSRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases.**

1.3. The APSRRDA shall utilize the amount released under Administrative Fund as per revised Para 12.2 of the Programme Guidelines vide the Ministry's Circular No. P-12014/1/2014-RC dated 29th October, 2018.

1.4. Andhra Pradesh State Rural Roads Development Agency (APSRRDA) has nominated **Shri R. Venkateswara Rao, Engineer-in-chief** as the Empowered Officer of APSRRDA. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

1.5. The funds released by the State Government shall be kept in a separate Savings Bank Account No.110510011001630 (IFSC Code No. ANDB 0000606), Andhra Bank Building, R.R. Street, Vijayawada-520001.

1.6. No Utilization Certificate is pending from Andhra Pradesh State Rural Roads Development Agency (APSRRDA).

1.7. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.

1.8. The expenditure is debitable to the following Head of Accounts under **Demand No.82** Department of Rural Development (2018-19).

- 3601 - Grants-in-aid to State Government (Major Head).
- 06 - Centrally Sponsored Schemes
- 101 - Central Assistance/Share
