I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to Rs.8,62,51,000/- (Rupees Eight Crore, Sixty Two Lakh and Fifty One Thousand only) as 1<sup>st</sup> installment towards Administrative Fund to the State Government of Arunachal Pradesh as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2018-19.

2. The State Government must transfer these funds to Arunachal Rural Roads Development Agency (ARRDA) within 3 working days positively from the date of receipt of these funds. - 4. The funds transferred by the State Government to ARRDA shall be kept in a separate Saving Bank Account No.10940060646 (IFSC Branch Code No. SBIN0006091), State Bank of India, Itanagar Branch, Arunachal Pradesh.
- 5. The ARRDA shall utilize the amount released under Administrative Fund as per revised para12.2 of the programme guidelines issued vide this Ministry's Circular No.P-12014/1/2014-RC dated 20.5.2014.
- 6. No Utilization Certificate is pending from Arunachal Rural Roads Development Agency (ARRDA), Itangar.
- 7. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.
