Subject: Release of 2nd installment of Administrative Fund to the State Government of Arunachal Pradesh under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2018-19.

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs.10,37,49,000/- (Rupees Ten Crore Thirty Seven Lakh Fourty Nine Thousand only)** as 2nd installment towards Administrative Fund to the State Government of Arunachal Pradesh as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2018-19**.

2. **The State Government must transfer these funds to Arunachal Rural Roads Development Agency (ARRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer of funds beyond this period, Central Government may be constrained to stop further releases.** The State Government is required to endorse a copy of the release order to the Government of India at the following address:

3. **Arunachal Rural Roads Development Agency (ARRDA) has nominated Shri D. Nyodu, Chief Engineer, Rural Works Department, as the Empowered Officer.**

4. **The funds transferred by the State Government to ARRDA shall be kept in a separate Saving Bank Account No.10940060646 (IFSC Branch Code No. SBIN0006091), State Bank of India, Itanagar Branch, Arunachal Pradesh.**

5. **The ARRDA shall utilize the amount released under Administrative Fund as per revised para 12.2 of the programme guidelines issued vide this Ministry's Circular No.P-12014/1/2014-RC dated 20.5.2014.**

6. **No Utilization Certificate is pending from Arunachal Rural Roads Development Agency (ARRDA), Itanagar.**

7. **The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.**

8. **The expenditure is debitable to the following Head of Account under Demand No.82 Department of Rural Development during the current Financial Year (2018-19):-**

9. Secretariat of the Election Commission of India, New Delhi has stated that release of funds under PMGSY would be subject to the following conditions:-

- (i) There shall be no publicity in this regard in electronic, print, radio, internet or any other media, in any form whatsoever.
- (ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.
- (iii) These restrictions on publicity will be applicable to the Central Government as well as State Governments concerned.
- (iv) The relevant provisions of Model Code of Conduct (MCC) issued by the Commission shall be strictly followed.
- (v) No new work shall be taken up afresh during MCC period.

10. The Assistant Director, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Government of Arunachal Pradesh.
