**Subject: Release of Administrative Fund to State Government of Assam under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2018-19.**

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 6.581 crore (Rupees Six Crore Fifty Eight Lakh and Ten Thousand only)** as 1st installment towards Administrative Fund to the State Government of Assam as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2018-19**.

**2. The State Government must transfer these funds to Assam State Road Board (ASRB) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may consider to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is required to endorse a copy of the release order to the Government of India at the following address:**

**3. Assam State Road Board (ASRB) has nominated Shri Dibyajyoti Saharia, Chief Engineer, PWD (Roads), Government of Assam, Chandmari, Guwahati-781003 as the Empowered Officer.**

**4. The funds transferred by the State Government to ASRB shall be kept in a separate Saving Bank Account No. 10566991457 in State Bank of India, (IFSC Branch Code No. SBIN0000221), State Bank of India, New Guwahati Branch, Dist. Kamrup, Guwahati-781021.**

**5. No Utilization Certificate is pending from Assam State Road Board (ASRB), Guwahati.**

6. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.

7. The expenditure is debitable to the following Head of Account under **Demand No.- 82** Department of Rural Development during the current financial year (2018-19):-

- 3601 - Grants-in-aid to State Government (Major Head).
- 06 - Centrally Sponsored Schemes
- 101 - Central Assistance/Share
- 30 - Pradhan Mantri Gram Sadak Yojana

8. The Pay & Accounts Officer, Ministry of Rural Development will be the Drawing and Disbursing Officer for this purpose. The amount mentioned in Para-1 above will be transferred to State Government of Assam.
