I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to Rs.36,02,000/- (Rupees Thirty Six Lakh and Two Thousand Only) towards 1st instalment of Administrative Fund to the State Government of Haryana as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2019-20.

2. The State Government must transfer these funds to State Rural Road Development Agency within 3 days positively from the date of receipt of these funds. In case of non transfer beyond this period, Central Government may be considered to stop further releases. The State Government is requested to endorse the copy of the release order to the Central Government addressed as under;

- 3. The Haryana Rural roads & Infrastructure Development Agency (HaRRIDA) has nominated **Shri Arvind Kumar**, **Chief Engineer cum Executive Director**, (HaRRIDA) as the Empowered Officer of HaRRIDA (PMGSY).
- 4. The funds released by the State Government shall be kept in a separate savings Bank Account No. 65038038370 (IFSC Code No.SBIN0003246), State Bank of India, Code (03246) Sector 7-C, Chandigarh,
- 5. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 6. The HaRRIDA shall utilize the amount released under Administrative Fund as per revised Para 12.2 of the Programme Guidelines vide the Ministry's Circular No. P- $\frac{12014}{1/2014}$ -RC dated $\frac{20^{th}}{1/2014}$ -RC
- 7. No Utilization Certificate is pending from Haryana Rural Roads & Infrastructure Development Agency (HaRRIDA).

- 8. Utilisation Certificate should be submitted within 12(twelve) months of the closure of the Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the ledger accounts for the purpose.
- 9. The Accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the O/o the CCA of the Ministry in terms of Rule 211 (1) of the General Financial Rules.
- 10. The expenditure is debitable to the following Head of Accounts under **Demand No.84** Department of Rural Development (2019-20):
