In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. - 4. Odisha State Rural Connectivity Project Agency (OSRCPA) has nominated Shri A.K.Tripathy, Chief Engineer (D.P.I & Roads), Odisha.
- 5. The funds transferred by the State Government to OSRCPA shall be kept in a separate saving Bank Account No. 37370025848 (IFS Code: SBIN0000041) in State Bank of India, Bhubaneshwar Main Branch, District Khurda, Odisha 751009. It shall be ensured by Odisha State Rural Connectivity Project Agency (OSRCPA) that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the Odisha State Rural Connectivity Project Agency (OSRCPA) shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

- 6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 7. No Utilization Certificate is pending from Odisha State Rural Connectivity Project Agency (OSRCPA).
- 8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.
- 9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211(1) of the General Financial Rules.
