Sub: Release of Grants-in-aid to the State Government of Meghalaya under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2018-19's 2nd installment.

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs. 97,75,00,000 (Rupees Ninety Seven crore and Seventy Five Lakh only)** to the State Government of Meghalaya as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) towards the Financial Year 2018-19's 2nd installment.

2. The abovesaid Sanction is made under World Bank (RRP II) and the amount of Rs. 97.75 cr as 2nd installment of the year 2018-19 is being adjusted as per details given below:

3. The State Government must transfer these funds to Meghalaya State Rural Road Development Agency (MSRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @12% for the period of delay beyond the specified period.

4. Meghalaya State Rural Road Development Agency (MSRRDA) has nominated Shri. Paul.R. Marwein, Secretary cum Additional Chief Engineer, P.W.D. (Roads) as the Empowered Officer of Meghalaya Rural Roads Development Agency (MSRRDA). The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

5. The funds released by the State Government shall be kept in a separate Savings **Bank Account No. 10407610364 (IFSC Branch Code No. SBIN0006320), State Bank of India, Meghalaya Secretariat, MG Road, Shillong-793001**. It shall be ensured by the Meghalaya State Rural Road Development Agency (MSRRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Meghalaya State Rural Road Development Agency (MSRRDA) shall communicate to the bank the names of the Authorised Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Meghalaya State Rural Road Development Agency (MSRRDA)**.

8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211(1) of the General Financial Rules.


9. The expenditure is debitable to the following Head of Accounts under **Demand No. 82 Department of Rural Development (2018-2019)**.


