The funds will be transferred by the State Government to Bihar State Rural Road Development Agency (BRRDA) in their saving Bank Account No. 11111137916 (Old Account No. 01100050390) (Branch Code No. 006379), IFSC Code SBIN0006379 in State Bank of India, Bailey Road Branch, Patna. In case of non transfer beyond the stipulated period in para-2 above, Central Government may be constrained to stop further releases to the State. Besides, the State Government would be liable to pay interest @12% per annum for the period of delay beyond the specified period to BRRDA. Thereafter, the above funds, along with the interest if any, will be transferred by the BRRDA within 3 working days positively from the date of receipt of these funds to NBCC to their current account No.352401010035007, Union Bank of India, Lodhi Colony, New Delhi, (Branch Code-535249) MICR Code 110026017 (IFS Code-UBIN535249). In case of non transfer beyond the stipulated period in para-2 above, Central Government may be constrained to stop further releases to the State. Besides, the BRRDA would be liable to pay interest @12% per annum for the period of delay beyond the specified period to NBCC. The BRRDA is required to endorse the copy of the transfer of funds to the Government of India to the address mentioned in para-3 above.
- 5. This release to NBCC is towards agency fee in terms of clause 11.1 of the Tripartite Agreement dated 31st August, 2004, signed between M/s National Building Construction Corporation Limited, New Delhi, Rural Development Department, Government of Bihar and the Ministry of Rural Development. This amount will be adjusted towards 10% of the total project cost of awarded works.
