**Subject – Release of 2<sup>nd</sup> instalment of Annual Allocation 2018-19 to State Government of Nagaland under Pradhan Mantri Gram Sadak Yojana (PMGSY)- Administrative Fund.**

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs. 1,50,75,000 (Rupees One Crore Fifty Lakh and Seventy Five Thousand only)** as 2<sup>nd</sup> instalment of Administrative Funds to the State Government of Nagaland under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2018-19.

2. The State Government must transfer these funds to Nagaland Rural Roads Development Agency (NGRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

3. The NGRRDA shall utilize the amount released under Administrative Fund as per Para 12.2 of the Programme Guidelines.

4. Nagaland Rural Roads Development Agency (NGRRDA) has nominated **Er. Limadongdang Jamir, Chief Engineer (PWD) and Empowered Officer of NGRRDA.** The State Government is required to endorse a copy of the release order to the Government of India.

5. The funds released by the State Government shall be kept in a separate Savings **Bank Account No. 34199849567 (IFS Code No.SBIN0000214), State Bank of India, Main Branch, Kohima, Near Deputy Commissioner's Office, Kohima, Nagaland.**

6. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Nagaland Rural Roads Development Agency (NGRRDA).**



8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the O/o the CCA of the Ministry in terms of Rule 211(1) of the General Financial Rules.


9. The expenditure is debitable to the following Head of Accounts under **Demand No.82** Department of Rural Development (2018-2019).


