Subject – Release of Grants-in-Aid to M/s. National Hydroelectric Power Corporation Limited (NHPCL) for implementation of the Pradhan Mantri Gram Sadak Yojana (PMGSY) in Bihar for the year 2018-19.

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs 4,18,00,000/- (Rupees Four Crore Eighteen Lakh Only)** to the State Government of Bihar as the Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the financial year 2018-19.

2. The State Government must transfer these funds within 3 working days positively from the date of receipt of these funds to Bihar State Rural Road Development Agency (BRRDA) which in turn would transfer these funds to M/s National Hydroelectric Power Corporation Limited (NHPCL) having their registered office at NHPCL Office Complex, Sector 33, Faridabad, Haryana.

4. **The funds will be transferred by the State Government to Bihar State Rural Roads Development Agency (BRRDA) in their saving Bank Account No. 11111137916 (Old Account No. 01100050390) (Branch Code No. 006379), IFSC Code SBIN0006379 in State Bank of India, Bailey Road Branch, Patna.** In case of non transfer beyond the stipulated period in para-2 above, Central Government may be constrained to stop further releases to the State. Besides, the State Government would be liable to pay interest @12% per annum for the period of delay beyond the specified period to BRRDA. The State Government is required to endorse the copy of the transfer of funds to the Government of India at the following address:

5. **Thereafter, the above funds, alongwith the interest if any, will be transferred by the BRRDA within 3 working days positively from the date of receipt of these funds to National Hydroelectric Power Corporation Limited (NHPCL) to their current account No. 00000010748956029, IFSC Code SBIN0001435, State Bank of India, Alankar Place, Boring Road, Patna, Bihar-800001, Bank Code No. 01435).** In case of non transfer beyond the stipulated period in para-2 above, Central Government may be constrained to stop further releases to the State. Besides, the BRRDA would be liable to pay interest @12% per annum for the period of delay beyond the specified period to M/s NHPCL. The BRRDA is required to endorse the copy of the transfer of funds to the Government of India to the address mentioned in para-3 above.

6. This release to M/s NHPCL is towards agency fee in terms of clause 11.1 of the Tripartite Agreement dated 31st August, 2004, signed between M/s National Hydroelectric Power Corporation Limited, New Delhi, Rural Development Department, Government of Bihar and the Ministry of Rural Development. This amount will be adjusted towards 10% of the total project cost of awarded works.

7. Utilisation Certificate should be submitted within 12(twelve) months of the closure of the financial year which shall include interest accrued. Interest accrued should be computed based on the details of the ledger accounts for the purpose.

8. No Utilization Certificate is pending from M/s NHPCL.

9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.

10. The expenditure is debitable to the following Head of Accounts under **Demand No. 82** Department of Rural Development (2018-2019).

- 3601 - Grants-in-aid to State Government (Major Head).
- 06 - Centrally Sponsored Schemes
- 101 - Central Assistance/Share
- 30 - Pradhan Mantri Gram Sadak Yojana
- 30.01 - Programme Component-PMGSY
- 30.01.35 - Grants for creation of Capital assets

11. The Pay & Accounts Officer, Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para -1 above will be transferred to State Government of Bihar.


