Subject – Release of Agency Fees to M/s National Buildings Construction Corporation Limited (NBCC), Odisha under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2018-19.

Sir,

I am directed to convey the sanction of the President of India for release of an amount of Rs.7,83,88,200/- (Rupees Seven Crore Eighty Three Lakh Eighty Eight Thousand and Two Hundred only) to the State Government of Odisha as the Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the payment of Agency Fees to M/s National Buildings Construction Corporation Limited (NBCC) for financial year 2018-19.

2. The State Government must transfer these funds to Odisha State Rural Road Agency (OSRRA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

3. The funds transferred by the State Government to OSRRA shall be kept in a separate saving **Bank Account No. 10872161766 (IFS Code: SBIN0041) in State Bank of India, Bhubaneswar Main Branch, District Khurda, Odisha– 751009.** It shall be ensured by **Odisha State Rural Road Agency (OSRRA)** that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the **Odisha State Rural Road Agency (OSRRA)** shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.


4. This release to NBCC is towards agency fee in terms of clause 9.1 of the Tripartite Agreement dated 4th March, 2015, signed between M/s National Building Construction Corporation Limited, New Delhi, Rural Development Department, Government of Odisha and the Ministry of Rural Development. This amount will be adjusted towards 10% of the total project cost of awarded works.

5. No Utilization Certificate is pending from NBCC.
6. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.
