**Subject: Release of 24.1015 Crore as Central Share of programme fund to the State of Andhra Pradesh for Road Connectivity Project for Left Wing Extremism Affected Area(RCPLWEA) under PMGSY for the financial year 2019-20-reg.**

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 24,10,15,000/- (Rupees Twenty Four Crore Ten Lakh and Fifteen Thousand only)** to Road and Building Department under the State Government of Andhra Pradesh for Road Connectivity Project on Left Extremism Area (RCPLWEA), as Central assistance (Programme Fund) under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2019-20**.

2. The amount of **Rs. 24.1015 Crore** released in the present sanction has been adjusted as per the details given below:

The State Government must transfer these funds to **Andhra Pradesh State Rural Road Development Agency (APSRRDA) under R & B Department** within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. **Andhra Pradesh State Rural Roads Development Authority (APSRRDA) under R & B Department** has nominated Shri P. Srimanarayana, Engineer-in-Chief as the Empowered Officer.



5. The funds transferred by the State Government to APSRRDA shall be kept in a separate **saving Bank Account No. 060610100150834 (IFSC Code-ANDB 0000606), Andhra Bank, Main Branch, R.R Appa Rao Road, Near Bodemma Hotel, Vijayawada-520001**. It shall be ensured by **Andhra Pradesh State Rural Roads Development Agency (APSRRDA) under R & B Department** that the Programme Implementation Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the **Andhra Pradesh State Rural Roads Development Agency (APSRRDA) under R & B Department** shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

10. The expenditure is debitible to the following Head of Accounts under **Demand No.84 Department of Rural Development (2019-20)**:

- 3601 - Grants-in-aid to State Governments (Major Head).
- 06 - Centrally Sponsored Schemes
- 101 - Central Assistance Share
- 30 - Pradhan Mantri Gram Sadak Yojana

11. The Assistant Director, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Government of Andhra Pradesh.
