- 4. Andhra Pradesh State Rural Roads Development Authority (APSRRDA) under R & B Department has nominated Shri P. Srimanarayana, Engineer-in-Chief as the Empowered Officer.
- 5. The funds transferred by the State Government to APSRRDA shall be kept in a separate saving Bank Account No. 060610100150825 (IFSC Code-ANDB 0000606), Andhra Bank, Main Branch, R.R Appa Rao Road, Near Bodemma Hotel, Vijayawada-520001.
- 6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 7. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.
- 8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.
