
5. The Assistant Director, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing & Disbursing Officer for the purpose.

8. This issues with the concurrence of the Integrated Finance Division vide their **U.O.No.1472/Finance/2018-19, dated 29.03.2019.**


