I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs.2.00 crore (Rupees Two Crore only)** as 1<sup>st</sup> Installment of Administrative Funds to the State Government of Tamil Nadu under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2018-19.

- 2. The State Government must transfer these funds to Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period.
- 3. The TNRHIDC shall utilize the amount released under Administrative Fund as per Para 12.2 of the Programme Guidelines.
- 4. Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC) has nominated Shri K.Baskaran, Director, Rural Development & Panchayati Raj Department, Government of Tamil Nadu as the Empowered Officer. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

- 5. The funds released by the State Government shall be kept in a separate Savings Bank Account No.10885934256 (IFSC Branch Code No.SBIN0013241), State Bank of India, Small and Medium Enterprises (SME) Chennai(13241), No.39, Prasanth Real Gold Tower, 6<sup>th</sup> Floor, North Usman Road, T. Nagar, Chennai-600017, Tamil Nadu.
- 6. No Utilization Certificate is pending from Tamil Nadu Rural Housing and Infrastructure Development Corporation (TNRHIDC).
- 7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

- 8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the O/o the CCA, Ministry of Rural Development in terms of Rule 211 (1) of the General Financial Rules.
- 9. The expenditure is debitable to the following Head of Accounts under **Demand No. 82** Department of Rural Development (2017-2018).
