Subject: Release of **Administrative Fund** to State Government of Uttar Pradesh under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2018-19 – reg.

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 7,32,00,000/- (Rupees Seven Crore Thirty Two Lakh Only)** to the State Government of Uttar Pradesh towards 2nd installment of Central assistance towards Administrative Fund under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2018-19**.

2. The State Government must transfer these funds to Uttar Pradesh Rural Roads Development Agency (UPRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

3. **Uttar Pradesh Rural Roads Development Agency (UPRRDA)** has nominated Shri Avdhesh Kumar Tiwari, Chief Executive Officer, UPRRDA as the Empowered Officer.

4. The funds transferred by the State Government to UPRRDA shall be kept in a separate **saving Bank Account No. 10616665816 in State Bank of India, Jawahar Bhawan, (Branch Code No. 6144), (IFSCCodeNo.SBIN0006144), Lucknow**. It shall not be transferred to any other account of the Agency without approval. It shall be ensured by the State Government that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of the **Uttar Pradesh Rural Roads Development Agency (UPRRDA)**, shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's Bank account for the purpose of this sanction.

5. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

6. No Utilization Certificate is pending from Uttar Pradesh Rural Roads Development Agency (UPRRDA), Lucknow.

7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose

8. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the O/o the CCA of the Ministry of Rural Development in terms of Rule 211, (1) of the General Financial Rules.

9. The expenditure is debitable to the following Head of Accounts under **Demand No.82** Department of Rural Development (2018-2019):

10. Secretariat of the Election Commission of India, New Delhi has stated that release of funds under PMGSY subject to following conditions:-

(i) There shall be no publicity in this regard in electronic, print, radio, internet or any other media, in any form whatsoever.

(ii) No political functionary shall make any reference in this regard during any public speech or communication to the press or public.

(iii) These restrictions on publicity will be applicable to the Central Government as well as State Governments concerned.


(iv) The relevant provisions of Model Code of Conduct (MCC) issued by the Commission shall be strictly followed.

(v) No new work shall be taken up afresh during MCC period.

11. The Assistant Director, PMGSY, Ministry of Rural Development, New Delhi (208139) will be the Drawing & Disbursing Officer for the purpose. The amount mentioned in Para-1 above will be transferred to State Government of Uttar Pradesh.

12. This issues under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their **U.O No 1408/Finance/2018-19 dated 22.03.2019**.
