**Subject: Release of Grants-in-aid (Programme Fund) to State Government of Uttarakhand as 2<sup>nd</sup> installment of Annual Allocation (AA) for year 2018-19 under Pradhan Mantri Gram Sadak Yojana (PMGSY).**

Sir,

I am directed to convey the sanction of the President of India for release of **Rs.489,37,50,000/- (Rupees Four Hundred Eighty Nine crore Thirty Seven Lakh and Fifty Thousand only)** to the State Government of Uttarakhand as Central assistance towards 2<sup>nd</sup> installment of AA, 2018-19 under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2018-19**.

2. The above said sanction is made under **World Bank (RRP-II)** and the amount of **Rs.489.375 crore** is being adjusted as per the details given below:

3. The State Government must transfer these funds to Uttarakhand Rural Roads Development Agency (URRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government would be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. Uttarakhand Rural Roads Development Agency (URRDA), Dehradun has nominated **Shri K.K. Srivastava, Chief Engineer**, Uttarakhand Rural Roads Development Agency (URRDA) as the Empowered Officer.

5. The funds transferred by the State Government to URRDA shall be kept in a separate **Saving Bank Account No. 30256973236 (IFS Code- SBIN0005713, Branch Code-05713) in State Bank of India, First Floor, Vindlas Complex, Rajpur Road, Dehradun**. It shall be ensured by **Uttarakhand Rural Roads Development Agency (URRDA)** that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies only for the purpose of approved works under the

Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of **Uttarakhand Rural Roads Development Agency (URRDA)** shall communicate to the Bank, the names of the Authorised Signatories, who will be issuing cheques on the Agency's said Bank Account for the purpose of this sanction.

6. The Empowered officer shall issue standing instructions to the Bank regarding the names of Authorised Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payment as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Uttarakhand Rural Roads Development Agency (URRDA), Dehradun.**

8. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules (GFR).

9. The expenditure is debitable to the following Head of Account under **Demand No.82** of the Department of Rural Development during the current financial year **2018-19**:-

- 3601 - Grants-in-aid to State Government (Major Head)
- 06 - Centrally Sponsored Schemes
- 102 - Externally Aided projects-grants for Centrally Sponsored Schemes
- 30 - Pradhan Mantri Gram Sadak Yojana
- 30.02 - Program Component-PMGSY (World Bank)
- 30.02.35 - Grants for creation of capital assets

10. The Assistant Director, PMGSY, Ministry of Rural Development will be the Drawing and Disbursing Officer for this purpose. The amount mentioned in Para-1 above will be transferred to state Government of Uttarakhand.
