**Subject– Release of Administrative Fund to State Government of Sikkim under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2019-20.**

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to **Rs.4,39,00,000 crore (Rupees Four Crore Thirty Nine Lakh only)** as 1<sup>st</sup> instalment towards Administrative Funds to the State Government of Sikkim under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2019-20.

2.1 The funds will be released to the State Government as per the Bank details given below:-

2.2 **The State Government must transfer these funds to Sikkim Rural Roads Development Agency (SRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases.**

3. The funds released by the State Government shall be kept in a separate savings Bank Account No. 11018615051 (IFS Code No.SBIN0000232), State Bank of India, Gangtok Branch, M.G Road, Sikkim-737101.

4. Sikkim Rural Roads Development Agency has nominated **Shri R.K. Pariyar, Chief Engineer, Rural Works Department**, as the Empowered Officer of Sikkim Rural Roads Development Agency (SRRDA). The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

5. The SRRDA shall utilize the amount released under Administrative Fund as per revised Para 12.2 of the Programme Guidelines vide the Ministry's Circular No P-12014/1/2014-RC dated 20<sup>th</sup> May, 2014

6. No Utilization Certificate is pending from **Sikkim Rural Roads Development Agency (SRRDA)**.

7. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211(1) of the General Financial Rules.




