# 2. Current Proposal of the State Govt. under PMGSY-III, Batch-II of 2019-20.

A presentation on the proposal submitted by the State was made by NRIDA before the Pre-Empowered Committee. The details of the proposal are as under:-

#### 3. DPR Issues.

- i. State needs to certify that the proposed alignments are as per the road alignments approved by the MHA.
- ii. DPR is prepared for 7 km length for the road package no. AP20LWE29. However, the length indicated in Proforma C and uploaded on OMMAS is 6.50 Km. The CC portion needs to be deducted in GSB, WMM and BT.
- iii. Average cost/km is on the higher side when compared to previous sanctions.
- iv. Agency area allowance for labours at the rate of 25% included in the rate analysis needs be deleted as per NRIDA letter no. P-17023/5/2017-P-I dated 25.01.2019 or should come from the State share.
- v. CC pavement proposed in open area needs to be deleted.
- vi. Transect walk format and Transect walk photographs are not attached.

- vii. Earth work Quantity seems to be on the higher side. In the absence of L&X section drawings, quantities could not be verified.
- viii. Test results for GSB materials are not attached with the DPR.
- ix. Soil tests have been conducted in PIU laboratory. State should certify that the PIUs are having laboratory facilities with required equipments.
- x. Credit has not been given for hard rock quantity. It should be utilized in pavement work (AP20LWE29).
- xi. Protection works need to be justified and rationalized with L and X section drawings and clear colored photographs.
- xii. Provision for encasing the pipe with M15 concrete made which needs to be deleted.
- xiii. Sand bedding proposed in CD works needs to be deleted as the soil is good.
- xiv. Higher number of CDs proposed in the DPRs without proper justifications. Needs to be justified with L and X section drawings.
- xv. In maximum DPRs, Metal Crash Barrier proposed. The state needs to replace it with the parapet wall.
- xvi. More than 15 m CD works included in the road DPR (AP20LWE29). Needs to be separated and should be proposed under Bridge module.
- xvii. Provision for Unforeseen items and price escalation is not permitted under PMGSY. Needs to be deleted or it should come from State share.
- xviii. The seigniorage charges added with the basic rate for individual materials and the same rate must have been considered in the rate analysis. But as per the General Abstract attached in the DPRs, the seignorage charge is again considered, which is around 4% of the total cost.

#### 4. Maintenance.

Committee has agreed to the State's proposal of Rs 387.25 lakhs (6.66 % of Construction Cost) for 5 years Routine Maintenance, However, State needs to increase provision under 6<sup>th</sup> year's renewal from Rs 694.5 lakhs (11.95 % of Construction Cost) to at least 18 to 20 %. State has to propose separate maintenance head in the State Budget as pre-requisite of PMGSY III.

#### 5. R&D technology.

State has not proposed any road using new technology under RCPLWE.

Progress under RCPLWEA has not been satisfactory so far and Committee advised the State to expedite the pace of road construction and complete at least 80% of Phase I as promised earlier.

## 7. Quality Control.

Out of 21 no. of ongoing packages, labs have not been established in 14 packages. 1 ATR against ongoing work is pending with state which needs to be submitted immediately.

## 8. Fund Position.

Rs 326.95 crore (Central share: Rs 194.22 crore, State share: Rs 132.73 crore) are yet to be credited to SRRDA. Auditor has pointed out the issue of late transfer of fund from State treasury to SRRDA's Bank Account. Out of 10 works, 8 are pending for financial closure, out of which 1 is pending for more than 180 days. There is heavy balance in Saving Bank Account of Rs 28.93 crore causing loss of Interest which needs immediate attention of the State.
