Subject: Installation of GPS System in Key machinery & Equipment's engaged during execution of road works under PMGSY-III

Dear Sir/ Madam

This is in continuation of letter of even No dated 31st January, 2022 from Additional Secretary, MoRD & Director General, NRIDA on the subject mentioned above.

In this connection, I am directed to inform that based on feedback received from different stakeholders, the following amendment has been made in Para 4 of Point No 5 of the said guidelines:

As per Present Guidelines:

Point No. 5. GPS Vehicle Tracking System Workflow

"The vendor will set up a GPS Device on the vehicle and this device will provide the live location of the vehicle and map the data on Google MAP. The vendor does have their own GPS Vehicle Tracking System wherein the following three types of users which will use the this system:

- NRIDA level user
- 2. SRRDA level user
- 3. PIU level user"

Amended Guidelines:

Point No. 5. GPS Vehicle Tracking System Workflow

"Prospective bidders / vendors are advised to use any digital MAP services hosted in the geographical territory of India. These digital MAP services should be able to integrate with prevalent digital MAP Services such as Bhuwan MAP, Google MAP, Open Street MAP, MapMyIndia etc. The bidders/ vendors should have their own GPS Vehicle Tracking System which will be used by the following three levels of users for monitoring purpose:

- NRIDA level user (National level)
- SRRDA level user (SRRDA level)
- 3. PIU level user (District level)

It is also informed that the installation of the GPS based vehicle tracking system should not be entrusted to road contractor through the incorporation of clause in the bid, as it will create a conflict of interest and road contractor may manipulate the GPS data.

Financial implication on this account may be borne out of Admin fund held with SRRDA.
