**Subject: Updating of Proforma C-reg.**

**Sir/ Madam,**

As you are aware, Revised Proforma C (2021) with Checklist (Roads) for the use of PIU and STA under PMGSY-III was issued vide letter No NRRDA-P014(12)/1/2021-(Tech) dated 5.8.2021, wherein it is mentioned that after signing by the STAs, the signed Proforma C (2021) with Checklist should be uploaded on OMMAS under proposal module by the PIUs and the same shall be ensured by the STAs before scrutinizing the proposals on OMMAS.

It is observed that many of the States are not uploading the revised Proforma- C and they are still uploading the old Proforma- C. Further the proposals of the States, which are placed before Pre-EC/EC after duly scrutiny by the STAs and uploaded on OMMAS, may undergo revisions or modifications as per observations of NRIDA on sample DPR scrutiny and/ observations of Pre-EC/EC. The States are to upload the revised provision of DPRs including the change of any technology on proposal module as their final proposal on OMMAS for sanction. But in spite of repeated instructions, the States are not revising the Proforma-C based on the revised provision made in the DPRs and uploading the same on OMMAS. As a result of which it becomes difficult to monitor the sanctioned projects in a later stage. It is to intimate that, OMMAS has provision to upload the updated Proforma-C multiple times, whenever there are any changes made in the DPRs. The final Proforma-C uploaded on the OMMAS should be as per provisions made in the final DPRs considered for sanction.

In view of above and to obviate the difficulties being experienced in tracking the actual provision made while sanctioning PMGSY the projects, it is requested to please update the Proforma-C of all the sanctioned works under PMGSY-III works as per the final provision made in the DPRs before sanction of the proposals duly authenticated by the STA. This exercise may please be completed by 15<sup>th</sup> July 2023 positively and compliance be reported.

This may please be treated on priority please.
