Dear *Madam/Sir*

Your attention is invited to letter of even no. dated 16.05.2018 from Director (Technical), NRIDA indicating the annual targets for the year 2018-19 of road length to be constructed using non-conventional materials and green technologies under R&D category.

2. The states were informed that in order to achieve the overall annual targets under R&D, apart from completing the works sanctioned under Green Technologies, the states were given flexibility to make appropriate changes in the already sanctioned works for adoption of Cold Mix Technology/ Waste Plastic technology in place of hot mix technology.

3. However, the review of the completion of R&D works from April, 2018 to till date indicates very minimal and insignificant progress, vis-a-vis the state-wise R& D targets fixed for the financial year 2018-19. I am enclosing herewith the state wise allocation of targets and achievement made as per the data available in OMMAS.

4. You are requested to kindly direct the concerned officials that appropriate action may be taken to expedite the road works under R&D category so as to achieve the targets for the year 2018-19. PIUs wise target may be set based on R&D length sanctioned and this should be reviewed on regular basis in order to achieve the target. You will appreciate the importance and priority given by MoRD and NRIDA to the R&D works and I may also remind you that the achievement of R&D targets is one of the criteria for award of Incentive Funds under PMGSY.

5. I hope there will be improvement in the coming months. Further, it is also requested to make an officer responsible at SRRDA to closely monitor the progress of R&D works and uploading of such data regularly on the OMMAS, as all progress reports are being considered only as per OMMAS.

6. Your cooperation in this regard is requested.
