# Minutes of the Regional Review Meeting for the States of Himachal Pradesh and Uttarkhand and Union Territories Jammu & Kashmir and Ladakh on 16<sup>th</sup> January, 2020 at India Habitat Centre, New Delhi

A regional review meeting was held on 16<sup>th</sup> January, 2020 at New Delhi under the chairmanship of Additional Secretary (RD), MoRD & DG, NRIDA for Himachal Pradesh, Uttarkhand, Jammu & Kashmir and Ladakh to have an intensive discussions on issues like Progress Monitoring, Planning, New and Green Technology, Contract Management, Finance & Accounts, Quality, Maintenance Management etc. The meeting was attended by State officials, Director (RC), MoRD and Director(s) from NRIDA.

At the outset, Director (Projects-I) welcomed the AS(RD), MoRD and DG, NRIDA, Directors of NRIDA, and State representatives who have come to attend this Regional Review Meeting of PMGSY. He informed that this is the 2<sup>nd</sup> review meeting of the States during this FY 2019-20. The workshop was inaugurated by lighting the lamp.

AS (RD), MoRD and DG, NRIDA also thanked the SRRDA, officials for attending this Regional Review Meeting at New Delhi. She informed that we are nearly on the completion stage of connectivity under PMGSY-I. Recently Hon'ble Minister of Rural Development has taken intensive review of various schemes of Rural Development and desired to reach connectivity status to 100% from 97%. Hon'ble MRD also desired to identify such roads which are more than 4 years old and not yet awarded, no further funds shall be released for these works, if it is not completed by March, 2020, States shall bear all the cost from the State budget on these roads, if not completed by March 2020. The SRRDAs should emphasis more on completion of PMGSY I and PMGSY-II targets. DG, NRIDA informed that Secretary, RD, Government of India prepared teams of officers who will visit SRRDAs to get the figures which we have to chase. We may also foreclose the Roads which are upto to the WBM level. SRRDAs should pay more attention to the awards of works since this is method of pushing the Governance agenda. DG, NRIDA desired that the 3 participating states should concentrate more on finishing the in-progress work and the states may start preparation of PMGSY-III during rainy season so that they may join PMGSY-III Project in next financial year. IT Nodal officer of SRRDA plays a key role in regular updation of data on OMMAS therefore there is need that ITNOs should regularly be in touch with PIUs for updating the completion data and there is a need that one officer of the level of Superintending Engineer/ Executive Engineer should be with ITNO to speed up the progress. GIS mapping is to be given high priority as it is primary criteria for sanction of PMGSY-III. DG, NRIDA informed that no further sanctions will be given under PMGSY-I as the cut off date was March 2019. She further informed that the cut off date for PMGSY-II will be March 2020.

DG, NRIDA also presented a brief overview of performance by States with regard to progress, achievement of targets, quality, finance, green technology, maintenance monitoring, etc. In her address, emphasize was given on upkeep and maintenance of roads. States need to focus on maintenance budget planning, monitoring system etc. The comparison was also shown to the States w.r.t the achievement in the quarter of 2018-19 and 2019-20 (upto Dec. 19) Himachal Pradesh (1,335 km in 2018-19 & 815 km in 2019-20), J&K (1,622 km in 2018-19 & 1,265 km in 2019-20) and Uttarakhand (1,757 km in 2018-19 & 960 km in 2019-20). Pace of constructions are relatively slow with comparison to the achievement made during last year upto

Dec. 2019. States have been advised to increase the pace of work in the remaining period. DG, NRIDA desired to expedite the completion of works under PMGSY-I and the States should have a completion plan to complete the works latest by June, 2020. Participating States were requested to focus on completion of ongoing works on priority, so that the States may switch over to PMGSY-III by next financial year.

States were also advised to submit proposals for dropping of roads which are not feasible. DG, NRIDA further stressed the necessity of close monitoring of physical progress and bringing down the time gap between tendering and awarding of works. Approximately, 8081 km of road length (PMGSY-I &II) is lying unawarded against the total balance length of 21,628 km across the country with these four States/UTs. Against the total 8,081 km unawarded road length, majority of the length remains to be awarded by the States of Himachal Pradesh (608 km PMGSY-I and 1,251 km PMGSY-II), Jammu & Kashmir (1419 km PMGSY-I and 705 km under PMGSY-II), Ladakh (32 km PMGSY-I and 79 km PMGSY-II), and Uttarakhand (3,081 km PMGSY-I and 906 (PMGSY-II). Out of total balance length under PMGSY (all schemes), maximum road length to be constructed under PMGSY-I by these States. There is a need for improvement in execution capacity in the State of Himachal Pradesh.

AS (RD) briefed about pending roads, especially that are more than 4 years old need to be completed by March, 2020. Out of total 2,797 works pending for 4 years nationally covering a 7075.24 km length, 66 roads (216 km) pending with Himachal Pradesh, J&K (341 nos. roads covering length 1,490 and 18 nos. bridges) and Uttarakhand (50 nos. roads covering a 222 km road length and 18 nos. of bridges). States were advised that in case, it is not feasible to complete these works by March, 2020 due to forest clearances, court cases or other reasons, the State should send the proposal for dropping now, with the reasons against each dropping. States were also advised by DG, NRIDA to submit realistic month-wise completion plan for old works more than 4 years which may include dropping proposals along with the reasons for delay in completion including multiple retendering. There is need to closely follow up with concerned PIUs and contractors. Keeping in view that beyond March 2020 the State would have to build the road of its own resources. States were advised to reduce the percentage of 'Unsatisfactory' grading in maintenance works as it is constantly being reviewed by NITI Aayog.

AS (RD) in her presentation briefed about pending works held up for completion due to forest clearance. States were advised to resolve the matter with the concerned department for early completion of these road works otherwise dropped these works.

AS (RD) further highlighted progress made by the States under Green Technology during the year 2019-20 and overall length sanctioned and achieved. She informed that out of the overall sanctioned length of more than 65,000 km under R&D more than 36,800 km has already been constructed. States were advised to speed up the progress of works under R&D, so that targeted length allotted to the States can be achieved by end of March, 2020, as the progress in the year 2019-20 is not up to the mark. Further, States were advised to submit the performance evaluation report for the good practices under R&D. Further, DG, NRIDA informed that under PMGSY-III, it is mandatory to propose 15% of the total road length proposed using waste plastic. Regular review at micro level should be conducted to achieve the target under R&D.

DG, NRIDA emphasized for strict quality control and quality works of highest standards as per norms of PMGSY. He also emphasized for proper maintenance of rural roads, emphasizing on preventive maintenance, 5 year Defect Liability Period (DLP), allocation of funds by State to ensure that PMGSY roads are in good condition during and after its design life period of 10 years.

DG, NRIDA stated that the maintenance of roads have to be taken on mission. It is about 5.20 lakh km of road length under maintenance. It is now required to initiate micro management maintenance contract. Maintenance funds required as per Contract, amount credited in account of SRRDA and amount utilized by SRRDA during last year and current year were also discussed. As per information received from the States, during the current fiscal year, in case of Himachal Pradesh the Maintenance amount required is 17.35 Cr, amount credited is 12.50 Cr and the amount spent is 5.85 Cr. In case of Jammu & Kashmir the Maintenance amount required is 6.80 Cr and the amount credited is 0.15 Cr and the amount spent is 1.88 Cr. In case of Uttarakhand the Maintenance amount required is 31.50 Cr, amount credited is 15.75 Cr and the amount spent is 4.02 Cr. DG, NRIDA informed that the % Unsatisfactory maintenance works in these states from April 18 to December, 2019 is 31.08% in case of Himachal Pradesh, 37.21% in case of J&K and 45.65% in case of Uttarakhand and all are on higher side. It was reiterated that maintenance of built assets is of utmost importance and the State needs to take a serious view of the same. States were advised to look into the matter with their respective finance department for release of funds.

State of Uttarakhand has balance length of 6957 km (1054 roads and 141 bridges) against the sanctioned length of 19,154 km. State has 221.62 km of length (50) roads and 18 bridges) pending for more than 4 years which is a cause of concern. Against the target of 2,500 km road length the State has so far completed only 960 km and as against the target of 507 habitations, only 62 habitations have been provided connectivity. The very slow pace of works with an achievement of only 960 km in the current year was pointed out as a major course of concern.

States were advised to speed up the execution of works in the remaining period of this financial year and all efforts should be made to achieve the annual targets. States were asked to submit the committed month-wise plan construction of balance road length against the target length to be constructed during 2019-20 as well as LSBs by end of March, 2020.

During the review meeting, Director (P-III & CQC) highlighted about the details of works sanctioned vis-a-vis field laboratories not established. The State-wise bifurcation is given below:-

CQC informed that as per Guidelines field labs should be established before start of work and percentage should be within 10%. SQCs of participating States were advised for close monitoring and ensuring all pending field laboratories shall be established at the earliest and uploaded on OMMAS also. State should take action against those contractors not establishing field laboratory at the site before start of work, no payment should be paid to the contractor without establishing the field laboratory.

In Himachal Pradesh, 36 works out of 258 works are such in which payment of more than one lakh has been made when the work has not been inspected even once by SQMs. In Jammu & Kashmir it is 47 out of 365 and in Uttarakhand it is 89 out of 187. Director (P-III) instructed all the SQCs of the participating States to look into this and assign these works for inspection on priority.

With respect to comparison of Grading of works by NQMS and SQM during 2019, Director (P-III)/ CQC informed that in the state of Himachal Pradesh total no. of roads inspected by SQM and NQM are 413 out of which no. of roads with same grading from NQM as well as SQM are 264 and no. of roads with mismatch grading are 149. In case of Jammu & Kashmir, total no. of roads inspected by SQM and NQM are 221, out of which no. of roads with same grading from NQM as well as SQM are 180 and no. of roads with mismatch grading are 41. For Uttarakhand, total no. for roads inspected by SQM and NQM are 391 out of which no. of roads with same grading from NQM as well as SQM are 264 and no. of roads with mismatch grading are 127.

CQC further highlighted details of works assigned and inspected by NQMs in December, 19 in respect of completed, in progress and roads under maintenance. In case of Himachal Pradesh, no. of works assigned were 47 and no. of works inspected by NQMs were 34; for Jammu & Kashmir, no. of works assigned were 20 and no. of works inspected by NQMs were 7 and for Uttarakhand no. of works assigned were 14 and no. of works inspected by NQMs were 13.

It was observed that for the project sanction year 2013-19, in the State of Himachal Pradesh 48 number of contractors, 131 contractors in case of Jammu & Kashmir and 45 contractors in Uttarakhand whose works have not been inspected even once by NQMs. SQCs were advised to assign these works for inspection on priority.

Director (P-III & CQC) further highlighted about pending ATRs w.r.t. Completed as well as ongoing works in the States. He informed that in case of Himachal Pradesh in completed works 13 ATRs and in ongoing works 83 ATRs are pending with States. In case of Jammu & Kashmir, in completed works 17 ATRs and in ongoing works 52 ATRs are pending with State. In case of Uttarakhand in completed works 7 ATRs and in ongoing works 59 ATRs are pending with State.

States were asked to resolve the issue of pending ATRs for both completed as well as ongoing works. It was reiterated that delay in submitting ATRs which were more than 5 years old recovery would be done for such works from the State Govt. States should give priority for SRI nature ATRs and submit within one month's time to NRIDA.

CQC pointed out that the poor maintenance of rural roads in these States is a cause of serious concern. He further informed about the % Unsatisfactory works in completed, ongoing and maintenance works category for the period (April 2011 to Dec. 2019) which are as follows:-The figures clearly points out that the quality of road deteriorated without proper maintenance. Hence the States were requested to spend the money allocated to them for maintaining of roads.

In respect of pending complaints, it was discussed that for the State of Himachal Pradesh 2 Complaints are pending out of which 1 sent to State and for 1 ATR pending with State of NQM inspection. For the state of J&K only 1 complaint is pending for which ATR is pending with the State of NQM inspection. In case of Uttarkhand 3 complaints are pending and for all the 3 complaints ATR pending with State of NQM inspection. States were advised to submit the reports without further delay.

CQC further briefed about complaints received on Meri Sadak App. Most of the complaints of these 3 states received were of "Abandoned works" and 'Poor Quality' of road works. In case of Himachal Pradesh, percentage of complaints of abandoned work is 23.47% and 39.21% of poor Quality. In case of Jammu & Kashmir, percentage of complaints of abandoned work is 19.24% and 42.14% of poor Quality. In case of Uttarakhand, percentage of complaints of abandoned work is 20.31% and 34.50% of poor Quality.

During discussions, it was pointed out that the present formats of NQM/SQM reports are too bulky and therefore needs to be streamlined. DG directed that a committee is to be formed by NRIDA to evolve a better format, using AI based technology and shall be comprehensive but not bulky, which shall be filled by NQM/SQM personally. Meanwhile all SRRDAs are requested to send their comments/ suggestions for these NQM/SQM format. The format is to be evolved and first such consultative workshop be held sometime in April, 2020.

Director (F&A) in his opening remarks highlighted common observation found in Auditor Report and Balance Sheet. The issue of impact of GST for all the works individually for all category of works indicated in the advisory already issued to all the States vide which States were advised to work out the impact of GST and submit detailed proposals based on the same. Any cost excess shall be borne by MoRD and the state in the existing Fund sharing pattern of PMGSY as may be applicable to the states. In spite of the above guidelines, it has been observed that the State(s) have not assessed the impact of GST holistically as per the guidelines and

instead are referring proposals in a piecemeal manner seeking additional funds. Participating States were requested to follow the guidelines and demand additional funds from Ministry of Rural Development, if required, after a complete analysis of all the pending cases.

Director (F&A) further informed that SRRDAs are not verifying the amount of interest being credited by banks in the saving bank accounts as well as Corporate Liquid Term Deposits (CLTDs) despite the auditors' comments. There are instances where banks delayed transfer of PMGSY funds to CLTDs account and have credited less interest than what was due in the SRRDA account. All such cases need to be checked and loss shall be recovered from bank for the period of delay. Non-verification of the amount of interest being credited by the banks is an important matter as this may lead to a loss of revenue if not checked meticulously. States were advised to give attention to this important matter of monitoring the timely transfer of funds to FDs/CLTD Account as per the guidelines and verify the interest earned thereon in the bank accounts of Programme, Administrative Expenses and Maintenance Funds regularly on a quarterly basis. In case any discrepancy is found in the calculation of the amount of interest, the matter should be taken up with the bank and the requisite amount recovered from bank.

Further, Director (F&A) highlighted the following issues related to finance and accounts:-

- Tax deducted at Source in Programme, Administrative and Maintenance Fund Account (Himachal Pradesh). Tax Deducted at Source in Programme Fund (Jammu & Kashmir and Uttarakhand). Large amount is pending as Stale Cheques which needs to be liquidated as early as possible (Himachal Pradesh and Jammu & Kashmir). States were advised to look into the matter with concerned department.
- Store issued to Contractor (Himachal Pradesh). Finance Controller informed that Rs. 0.06 crore pertains to 2 PIUs and assure that this will be resolved by end of this FY.
- Non Segregation of Bank balance with investment balance (Himachal Pradesh, Jammu & Kashmir and Uttarakhand). States were advised to pass the normal TEO entry on monthly basis.
- TDS has been deducted by Bank on the Interest Income (HP, J&K and UT). States were advised by the Director (F&A) to submit the exemption certificate to the bank so that the bank will not deduct the TDS amount on future income tax and States were also advised to follow up with IT Department for refund of earlier deducted TDS amount.
- Un-identified Difference in bank Account Balance and OMMAS (J&K).
- Payment to Contractor without deduction of GST-TDS (J&K)
- Cheques issued but not entered in OMMAS (HP).
- Liquidated damages not levied on the contractor for delay in completion of work (HP).
- Short deduction of security deposits in some cases (H.P).
- Pending Stale cheques (HP and J&K).

Director (F&A) further asked the States to take immediate action for dispose-off works pending for financial completion (Himachal Pradesh -104 out of which, 16 works are pending for more than six months; Jammu & Kashmir- 166 out of which, 82 works are pending for more

than six months and for Uttarakhand - 96 works out of 45 works are pending for more than six months). States were advised to provide detailed justifications with reasons (PIU name, package number etc.) duly signed by CEO/ENC/CE, if required in case of opening of lock for entry on OMMAS.

In respect of Fund Position for financial year 2019-2020, Director F&A informed that the percentage of Expenditure incurred in case of Himachal Pradesh is 48% in case of Jammu & Kashmir it is 80% and in case of Uttarakhand it is 49%.

Director (F&A) highlighted the status of PIUs registered on PFMS as on 14.1.2020. In case of Himachal Pradesh PIU as per OMMAS are 24 and registered on OMMAS are 24 similarly in case of Uttarakhand and Jammu & Kashmir PIUs as per OMMAS are 64 and 32 and registered on OMMAS are 53 and 30 respectively.

### Training Programmes for the Financial Year 2019-20

Director (P-II) informed about the training programmes scheduled for the last quarter of FY 2019-20 (January-March) at IAHE (Noida), CRRI (New Delhi) and ESCI (Hyderabad). He further advised the States that only the officers with less experience should be nominated for basic training courses and for refresher /advanced courses, only officers with adequate knowledge should be nominated. It was informed that it is planned to train 2,880 officials at different institutes such as IAHE, Noida, ESCI, Hyderabad, CRRI, New Delhi, NICMAR, Pune and AITD, New Delhi. Director (P-II) requested States to ensure full presence of the engineers nominated by the States at the training programme. If the nominated officer(s) is not in a position to attend the training programme, then other officer(s) may be nominated as replacement to ensure full participation of the training programme, so that the expenditures made for the training programme can be fully utilized and officers from SRRDAs may take full advantage of the training programmes.

While closing the Regional Review Meeting (RRM), the following main action points for time bound compliance, for all States, were reiterated:

- i. States should prioritize completion of tendering process and award of balance works and also encourage local contractors for prompt bidding.
- ii. States should submit the consolidated proposal of road works held-up for want of forest clearance/ wild life sanctuary and land problem, if any to MoRD/NRRDA.
- iii. States must quickly utilize the available financial resources and submit the utilization certificates promptly to the Ministry, for facilitating further releases.
- iv. States should achieve 100% physical target by March, 2020 both in terms of length and habitations.
- v. PIUs should ensure constant and regular uploading of details of connected habitations against partially completed road length on OMMAS. This should be reviewed periodically at the level of SRRDA.
- vi. All R&D stretches or R&D road length must be shown in R&D Module of OMMAS.
- vii. States should prepare systematic plan/ strategy for post 5 year maintenance of PMGSY road works.

- viii. States should ensure that the roads constructed under the PMGSY are maintained properly. Adequate funds for this purpose must be provided in the budget of the State.
- ix. State of Himachal Pradesh and UT of Ladakh should immediate initiative action to strengthening the SRRDA for PMGSY.
- x. States to focus on completing, particularly those roads which are pending completion for more than 4 years. The States to submit month-wise completion plan for the ongoing works.
- xi. States should submit consolidated proposal of road works not feasible for dropping to MoRD.
- xii. States should review the maintenance works/ bills quarterly or monthly basis and also upload the expenditure on Maintenance Module of OMMAS regularly.
- xiii. SQC should carefully scrutinize the lab details/ photos uploaded by PIU, while validating through their OMMAS login.
- xiv. Proper monitoring of ATRs by SQMs and SQC on the observations of the NQMs to be carried out before submission to NRRDA.
- xv. In all States/UTs, there are no. of works, where substantial payments have been made but no SQM inspections have been done. All such works should be inspected by SQMs on priority.
- xvi. State Quality Coordinators (SQCs) will give special focus to liquidation of pending ATRs, which would go a long way in improving the "Satisfactory" grading of PMGSY roads in their States.
- xvii. States agreed to concentrate on the clearance of pending final bills of the contractors and financially close the works on the OMMAS
