Dear Sir/Madam.

As you are aware, Prime Minister has given a call for "Swatch Bharat" as a mass movement to realize Mahatma Gandhi's dream of a clean India, by the 150th birth anniversary of Gandhiji in 2019. The Prime Minister has also desired that a nationwide campaign be organized by all Ministries and Departments to bring about a mass awareness and lasting behavioral change to achieve this goal. Under the aforesaid nationwide campaign, it has been proposed that an intensive national cleaniness campaign be undertaken from 25th September, 2014 and special events be organized on 2nd October, 2014.

- 2. For a campaign of this nature to be successful, there is a need to create massive public awareness and to ensure mass participation and action for cleaning our immediate surroundings including roads, culverts and bridges. This should be done in such a manner so that there is a "visible and felt impact".
- 3. Under PMGSY, all States are constructing good quality rural roads with first five-years maintenance built in the construction contract itself. In order to maintain and keep the PMGSY roads, road furniture and bridges/culverts clean, an intensive drive should be launched from 25th September, 2014 for a month and special events be organized on 2nd October, 2014. The focus should be to sensitize PMGSY road contractors, State agencies and local community regarding proper maintenance and cleaniness of these roads. The following work items for routine maintenance should be executed in a campaign mode –
- Clearing/re-shaping of road side drains
- Pothole filling
- Filling up edges of asphalt surface
- Dressing of berms, earth work on berms, rain cuts and dressing of earthen embankments, wherever necessary
- Refixing displaced guard stones, white washing guard stones, parapets of CD works
- Fixing and re-painting disturbed kilometer stones, caution boards, village sign boards, speed limit boards, PMGSY logo and citizen information boards
- White washing and geroo painting of trunks of trees on road flanks
- Cutting of branches of tress and shrubs which are obstructing flow of traffic and line of sight
- Maintenance of catch water drains, clearance and desilting of cross drainage works

- 4. It would help if meetings are organized at the level of SRRDA and/or PIUs with contractors responsible for carrying out the maintenance so that necessary man and material are mobilized in a campaign mode. Contractors should also be encouraged to engage local community in such maintenance works.
- 5. I look forward to hearing from you, latest by 29th September, 2014 on the arrangements made to undertake aforesaid activities as well as the comprehensive action plan of the State for maintaining these activities throughout the year.
