- 3. Rajasthan Rural Roads Development Agency (RRRDA), has nominated Shri Subodh Malik, Chief Engineer (PMGSY) as the Empowered Officer of RRRDA.
- 4. The funds transferred by the State Government to RRRDA shall be kept in a separate Saving Bank Account No. 10000950117 in State Bank of Bikaner & Jaipur, (IFS Code-SBBJ0010820, Branch Code-10820) PWD Complex, Jacob Road, Jaipur.
- 5. The RRRDA shall utilize the amount released under Administrative Fund as per revised Para 12.2 of the Programme Guidelines.
- 6. No Utilization Certificate is pending from Rajasthan Rural Road Development Agency (RRRDA).
- 7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose

- 8. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules (GFR).
