Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 79,68,000/- (Rupees Seventy Nine Lakh and Sixty Eight Thousand only)** to Panchayati Raj and Rural Development Department under the State Government of Andhra Pradesh for Road Connectivity Project on Left Extremism Area (RCPLWEA), as Central assistance (Administrative Fund) under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2020-21**.

2. The amount of **Rs. 0.7968 Crore** released in the present sanction has been adjusted as per the details given below:

In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. **Andhra Pradesh State Rural Roads Development Authority (APSRRDA)** has nominated **Shri B Subba Reddy**, Engineer-in-Chief as the Empowered Officer of APSRRDA.

5. The funds transferred by the State Government to APSRRDA shall be kept in a separate **saving Bank Account No. 110510011001630 (IFSC Code-ANDB 0000606)**, Union Bank of India, Vijayawada main branch, Andhra Pradesh.

6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

9. No Utilization Certificate is pending from Andhra Pradesh State Rural Roads Development Agency (ASPRRDA).

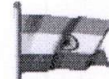

The proposal relates to 1st installment of Administrative Funds of Rs. 0.7968 Crores to the State Government of Andhra Pradesh under Road Connectivity Project of Left Wing Extremism Area (RCPLWEA).

2. It may be stated that the Clearance Letter dated 20th April (Page no. 985-988/Cor) has been issued for the sanctioning of 12 roads covering a length of 68.85 KM for the value of Rs. 53.12 Crore under RCPLWEA (Batch 1, 2020-21). Subsequently, the programme fund for the central share of Rs. 15.935 Crore has been concurred vide Note# 324-327.
