Subject- Release of 1st tranch of 1st instalment of Administrative Funds to State Government of Karnataka under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2020-21.

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid amounting to Rs.1,08,60,500/- (**Rupees One Crore Eight Lakhs Sixty Thousand and Five Hundreds only**) as 1st tranch of 1st installment of Central Assistance towards Administrative Fund under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State Government of Karnataka during the Financial Year 2020-21.

2. **The State Government shall transfer these funds along with the corresponding State Share to Karnataka Rural Roads Development Agency (KRRDA) within a maximum period of 15 days from the date of receipt of these funds.** In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

3. Karnataka Rural Roads Development Agency (KRRDA) has nominated **Shri Prabhakar D Hamigi as the Chief Operating Officer of KRRDA.**

4. The funds transferred by the State Government to KRRDA shall be kept in a separate **Savings Bank Account No. 043621700000022 in Syndicate Bank, J-652, Near Navrang Talkies, Dr. Rajkumar Road, Rajajinagar II Stage, Bangalore-560010 (IFSC Code No. SYNB0000436), Karnataka.**

5. The KRRDA shall utilize the amount released under Administrative Fund as per Para 12.2 of the Programme Guidelines.

6. No Utilization Certificate is pending from **Karnataka Rural Roads Development Agency (KRRDA).**

7. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.


8. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the O/o the CCA of the Ministry of Rural Development in terms of Rule 211 (1) of the General Financial Rules.
