**Subject: Release of partial payment of 2<sup>nd</sup> installment of Programme Fund of Annual Allocation 2020-21 to UT of Ladakh under Pradhan Mantri Gram Sadak Yojana (PMGSY) -reg.**

Sir,

1. I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 27,75,25,000/- (Rupees Twenty Seven Crore Seventy Five Lakh and Twenty Five thousand only)** to the Union Territory of Ladakh towards partial payment of 2<sup>nd</sup> installment as Central Assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the financial year 2020-21.

2. The amount of **Rs. 27.7525 crore** will be adjusted under the following phase:

3. **The UT administration must transfer these funds to Ladakh Rural Road Development Agency (LRRDA) within 15 working days positively from the date of receipt of these funds.** In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The UT administration is required to endorse a copy of the release order to the Government of India at the following address.

4. Ladakh Rural Road Development Agency (LRRDA) has nominated **Shri Tarsem Kumar, Chief Engineer PW(R&B)/PMGSY** as the Empowered Officer.

5. The funds released by the UT administration shall be kept in a separate Savings **Bank Account No.0069040100049849 (IFSC Branch Code No. JAKA0PRIEST), The Jammu and Kashmir Bank Ltd., Main Branch-Leh (0069).** It shall be ensured by the Ladakh Rural Road Development Agency (LRRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Ladakh Rural Road Development Agency (LRRDA) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

6. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Ladakh Rural Road Development Agency (LRRDA).**

8. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

9. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Officer of the Ministry of Rural Development in terms of Rule 211 (1) of the General Financial Rules.

10. The expenditure is debitable to the following Head of Accounts under **Demand No.85** Department of Rural Development (2020-21).




